Proposal: Printing signs for naturalized yards

February 27, 2024

#### Background:

In August 2023, ESACAC submitted recommendations for the Yard and Lot Maintenance By-law to be reviewed for clarifying the rules for naturalization. Council then passed a motion requesting that staff develop public education materials to support by-law enforcement, including information for recipients of by-law orders and prospective complainants. In January 2024, ESACAC submitted recommendations for public education materials, including a new webpage and content for an information pamphlet. In February, the Community and Protective Services Committee adopted changes to the by-law in alignment with staff recommendations. The updated by-law will be voted on by Council on March 5.

A key component of the transition to greater acceptance of naturalized yards is supporting Londoners to prevent conflicts with neighbours. It is generally recommended to communicate where landscaping is intentional, to help distinguish naturalized yards from neglected ones. Installing an information sign is a simple way to communicate the functions of and desire for a naturalized yard.

To encourage more Londoners to take up naturalization projects on private land, **ESACAC** proposes to use up to \$1,000 of the committee's annual budget towards printing yard signs that can be distributed in the community at no cost to residents. The signs could be printed on white corrugated plastic, similar to existing signs that the City distributes for residential rain garden projects (see below). It is recommended these new signs should be printed as soon as possible, ahead of the upcoming growing season.

ESACAC proposes the following language for the signs, with the web link made to align with the City's communications about naturalization and the Yard and Lot Maintenance By-law moving forward.

## **Nature lives here**

This area is maintained as wildlife habitat with plants providing community benefits.

At a recent meeting of our committee, we briefly discussed the Tree Protection By-Law. Staff indicated that the matters discussed should be referred to your committee for consideration. I am raising them directly with you through your Chair.

This document has two parts, describing two related issues:

- 1. Violations of the by law that occur without consequence (i.e., lack of enforcement)
- 2. Discrepancies between the map schedules referenced in the by law, and the London Plan

It is hoped that your committee will review these matters and make recommendations.

#### PART 1 - VIOLATION OF BY LAW

The Significant Woodland located at approximately 42.941566, -81.121247 (southeast of Veterans Memorial Parkway and Highway 401) was cut between 2022 and 2023 without a permit. Apparently the by law does not provide the City with the ability to enforce this unauthorized cutting. What changes are required so that enforcement can take place when cutting is detected? The current practice has a timing window for receiving complaints (21 days after a by-law violation) that seems too short for effective enforcement. It can be difficult to detect violations in a timely manner. In this example, it appears the violation was hidden behind a row of trees left on the west side of the property and by only "coring" the section to the east. Therefore, there may be a gap in the ability of the bylaw to deter violators.

#### London City Map



The area shown in the dotted circle below is where trees have been removed from a designated Tree Protection Area according to the <u>Key Map for Section B-16</u> under Schedule B of the Tree Protection By-law.




#### Questions for staff:

- 1. Why wasn't the Tree Protection By-law enforced in this case?
- 2. Why are only 21 days following a by-law violation allowed for complaints to be submitted?

#### PART 2 - MAPPING INCONSISTENCIES

Map 5 of the London Plan shows the Natural Heritage System. It would be expected that all parts of the Natural Heritage System shown on Map 1 (Place Types) and Map 5 would be included in maps of Tree Protection Areas. The following is an example of where that is not the case. It is suspected that there are other such examples across the City.

A wetland north of Skyline Avenue is marked in the dotted circle. It appears in Map 5 and Map 1 but it does not appear on the Tree Protection Area <u>Key Map for section B-2</u>.



#### **Questions for staff:**

1. Why are there discrepancies between the Tree Protection Area and Map 5 and Map 1 of the London Plan? How can these discrepancies be identified and corrected?
