Recommendation

That, on the recommendation of the Deputy City Manager, Finance Supports:

- a) This report providing an overview of the 2025 Annual Budget Update process **BE RECEIVED** for information; and
- b) Civic Administration **BE DIRECTED** to make the following amendments to the approved 2024 Council and Committee Calendar to accommodate the budget process timelines prescribed by "Strong Mayor" legislation:
 - i) Reschedule the Budget Committee meetings currently scheduled for November 28th and 29th to November 21st and 22nd to consider Council amendments to the 2025 Budget Update; and
 - ii) Schedule a special Council meeting on November 27th to formally adopt Council amendments to the 2025 Budget Update.

Linkage to the Corporate Strategic Plan

Council's 2023-2027 Strategic Plan for the City of London identifies 'Well-Run City' as a strategic area of focus. The City of London's Multi-Year Budget (MYB) process is specifically listed as a strategy under this strategic area of focus: 'Develop and monitor the Multi-Year Budget to align financial resources with Council's Strategic Plan.' The implementation of a MYB signifies that the City is looking beyond a short-term focus when planning its finances. This results in improved accountability and transparency over spending changes and helps the City maintain positive operating results, stable debt levels, and strong liquidity, reflected in the continued affirmation of the City's Aaa credit rating (47 consecutive years).

Analysis

1.0 Background Information

1.1 Previous Reports Related to this Matter

1.2 Strong Mayor Legislation – Impact on the Budget Process

On June 16, 2023, the Province of Ontario announced that it was extending "Strong Mayor" powers to 26 Ontario municipalities, including London, effective July 1, 2023. Similar powers had already taken effect for Toronto and Ottawa in November 2022 with the proclamation of Bill 3, Strong Mayors, Building Homes Act, 2022.

Section 284.16 of the Municipal Act describes the powers and duties of the Mayor with respect to the municipal budget process. Under the new "Strong Mayor" process, the power to propose and adopt the budget defaults to the Mayor and cannot be delegated. In addition, the powers are mandatory rather than permissive under section 284.16(2) and there is no 'opt-out' provision. O. Reg. 530/22 outlines prescriptive timelines and requirements for the passing of a budget. Under O. Reg. 530/22, the proposed budget must be prepared, presented to council and made public by the Mayor before February 1st each year. O. Reg. 530/22 further outlines the following timelines for the budget process:

- Within 30 days after receiving the proposed budget from the head of council, the council may pass a resolution making an amendment to the proposed budget (noting that the council may pass a resolution to shorten the 30-day period);
- If a council does not pass a resolution to amend the budget within the prescribed time period, the proposed budget shall be deemed to be adopted by the municipality;
- Within 10 days after the expiry of the time period for council to pass a resolution to amend the proposed budget, the head of council may veto a resolution passed by council (noting that the head of council may, in writing, shorten the 10-day period);
- If the head of council does not veto a resolution to amend the budget, the proposed budget shall be deemed to be adopted by the municipality with the council amendment;
- Within 15 days after the expiry of the time period for the head of council to veto a
 resolution to amend the budget, council may override the head of council's veto if
 two-thirds of the members of council vote to override the veto (noting that the
 council may pass a resolution to shorten the 15-day period);
- If council overrides the veto, the veto does not apply and the proposed budget is deemed to be adopted by the municipality with the council amendment.

This process can be summarized in the following graphic:

Mayor proposes a budget on or before Feb. 1st

Otherwise Council shall "prepare and adopt" the budget for the municipality



If no amendments (or not within 30 days), budget is deemed adopted as proposed by Mayor

10-day** period for Mayor to provide written veto of Council amendments

If no veto, budget deemed adopted with council amendments

15-day* period for Council to override Mayor's veto with two-thirds majority

If no two-thirds majority or not within 15 days, budget deemed adopted as proposed by Mayor

Budget deemed adopted with Council amendments

- * Council may pass resolution to shorten this time period
- ** Mayor may provide written document to shorten this time period

The 2024-2027 Multi-Year Budget was the first City of London budget process to be completed under the new "Strong Mayor" legislation and associated timelines. However, because the "Strong Mayor" powers were extended to London in the midst of the 2024-2027 Multi-Year Budget development period, it necessitated a unique process that resulted in a Civic Administration draft budget being released first on December 12, 2023 to facilitate public engagement and feedback, followed by the release of the Mayor's proposed budget on January 31, 2024. Council amendments to the Mayor's proposed budget were then approved on February 29, 2024. The 2024-2027 Multi-Year Budget process concluded with the deemed adoption of the budget on March 1, 2024

when Mayor Morgan announced that he was not intending to veto any Council amendments to the budget.

2.0 Discussion and Considerations

2.1 Proposed Timelines and Key Dates for the 2025 Annual Budget Update

For the 2025 Budget Update, a streamlined process is anticipated, with the release of only one budget document which will represent the Mayor's proposed budget. The proposed timelines are outlined in the following table, with the objective of completing the 2025 Budget Update process before the end of December 2024, while ensuring compliance with the legislative timelines outlined above.

The previously approved 2024 Council and Committee Calendar was created prior to the introduction of the new "Strong Mayor" legislation and associated budget timelines. This report seeks direction for Civic Administration to make the required changes to the 2024 Council and Committee Calendar to facilitate these timelines, specifically:


- Rescheduling the Budget Committee meetings currently scheduled for November 28th and 29th to November 21st and 22nd to consider Council amendments to the 2025 Budget Update;
- Schedule a special Council meeting on November 27th to formally adopt Council amendments to the 2025 Budget Update.

The other deadlines within the budget process can be accommodated within previously scheduled committee and council meetings.

3.0 Financial Impact/Considerations

3.1 2024-2027 Multi-Year Budget Recap

At the outset of the 2025 Budget Update process, the approved tax levy increase for 2025 is 8.7% as outlined in the following graphic (inclusive of the impacts of 2024 assessment growth):



Consistent with the Council approved Multi-Year Budget Policy, amendments to the 2024-2027 Multi-Year Budget will be supported by a Budget Amendment form and will be limited to the following matters:

- New or Changed Regulation A new or changed legislation or regulation with a financial impact to the municipality;
- New Council Direction A new Council direction that has transpired after the approval of the Multi-Year Budget; or
- Cost or Revenue Driver A budget adjustment required as a result of unanticipated changes since the approval of the Multi-Year Budget.

New for the 2025 Budget Update will be two separate categories of budget amendments: i) those that are included in the Mayor's proposed budget; and ii) those that are referred to the budget process but not included in the Mayor's proposed budget, if applicable. Including both categories of amendments will allow fulsome public engagement and Council debate on the various decision points in the budget.

4.0 Key Issues and Considerations

4.1 Potential Reductions to Future Years' Budgets

Recognizing the 8.7% tax levy increase currently approved for 2025, as well as the tax levy increases planned for 2026 and 2027, Civic Administration remains committed to the ongoing service review program that has been utilized for many years. Various service review "tools" continue to be utilized, including:

- Zero-based reviews and budget right-sizing
- Internal audit
- · Program reviews
- Organizational reviews

In particular, zero-based reviews are conducted on an ongoing basis and the results of these reviews are compiled into a budget amendment for inclusion in each year's Annual Budget Update. It is anticipated that a similar approach will be employed for the 2025 Budget Update. It should be noted, however, that because significant right-sizing was incorporated into the 2024-2027 Multi-Year Budget (more than \$36 million of total reductions were included in the 2024-2027 property tax supported budget), opportunities for right-sizing may be more limited in the 2025 Budget Update process than they are in the latter years of the multi-year budget cycle. Nevertheless, Civic Administration will bring forward right-sizing opportunities identified through 2025 budget development. Agencies, boards and commissions will similarly be encouraged

to thoroughly review their budgets and bring forward any opportunities for budget reductions.

In addition, Mayor Morgan has indicated his intention to establish a "Strategic Opportunities Review Working Group" with responsibilities including, but not limited to:

- conducting a strategic review of programs and services provided or funded by the City of London to identify potential divestiture opportunities, avenues for revenue generation, and/or alternate delivery models, in compliance with applicable legislation;
- exploring opportunities for shared services and revenue generation initiatives that align with the City's Strategic Plan and existing council direction;
- reviewing and considering service review opportunities for the City's boards and commissions.

Given the time required to operationalize the Strategic Opportunities Review Working Group, it is unclear the extent to which the recommendations of this working group will affect the 2025 budget. Any direction from Council (via this working group) to prepare budget amendments would need to be received by early August 2024 to provide sufficient time to develop the budget amendments and compile them in the budget document for release in October. It is likely that the outputs of this working group will more significantly inform the budget process in future years.

4.2 Public Engagement Approach

Civic Administration is still developing the public engagement plan for the 2025 Budget Update but would envision similar engagement activities to other annual budget updates. Anticipated engagement methods include, but are not limited to:

- Public participation meeting;
- Virtual and in-person information sessions;
- Support for Councillor ward meetings/townhalls (as requested);
- Attendance at community group events (as requested);
- Attendance at advisory committee meetings (as requested);
- Digital and print advertising in local media;
- Extensive use of social media:
- Continued use of the GetInvolved site:
- Continued use of Property Tax Breakdown Calculator tool;
- Budget materials available online and at all library branches;
- Availability of the Budget team by phone and e-mail.

As public engagement plans are formalized with a continuous improvement lens, consideration will be given to how to engage groups who have historically not participated in the municipal budget process.

Conclusion

Preliminary work on the 2025 Budget Update process, the first annual update to the 2024-2027 Multi-Year Budget and the second budget process under the new "Strong Mayor" legislation, is already underway. This report provides a summary of the anticipated process including a refresher on how the budget process is conducted in accordance with O. Reg. 530/22, the anticipated timelines and key dates in the process and the types of amendments that are anticipated in the 2025 Budget Update. This report also seeks approval to amend the Council-approved 2024 Council and Committee Calendar to accommodate the legislated budget process timelines.

Executive Summary

In June 2023, the City of London's Anti-Racism and Anti-Oppression division received funding from the Ontario Ministry of Citizenship and Multiculturalism to carry out the Anti-Hate Pilot Project.

The objectives of the project are to:

- Provide Londoners, service providers, and local partners with tangible tools for addressing hate and discrimination;
- Build capacity for City of London staff, the London & Middlesex Local Immigration Partnership, and other local organizations working in anti-racism, anti-oppression, and anti-hate;
- Increase community education and awareness on issues relating to anti-hate;
- Build an understanding of broader community education opportunities when addressing instances of hate; and,
- Demonstrate the effectiveness of collaboration between orders of government and a wide range of local community leaders and organizations.

Linkage to the Corporate Strategic Plan

The Anti-Hate Response Pilot Project is aligned with the Strategic Plan under the Reconciliation, Equity, Accessibility, and Inclusion strategic area of focus and supports the following outcome:

• The City of London is a leader in becoming an equitable and inclusive community.

The Pilot Project is also aligned with the strategic area of focus: Safe London for Women, Girls, and Gender-Diverse and Trans People with the following outcome:

 The City of London demonstrates leadership by taking meaningful actions to address and eliminate all forms of violence against women, and girls, gender-based violence, and sexual violence.

Analysis

2.0 Discussion and Considerations

2.1 Purpose

The purpose of this report is to provide a one-year update on the progress of Anti-Hate Pilot

Project and to outline the next steps.

2.2 Background

At the Annual General Meeting of the Association of Municipalities of Ontario in August 2022, a City of London delegation with the Minister of Citizenship and Multiculturalism discussed the need to combat racism, oppression and hate in Ontario.

In April 2023, the City of London's Anti-Racism and Anti-Oppression division submitted a proposal for funding to the Ontario Ministry of Citizenship and Multiculturalism. The proposal entitled "Working Together to Address Racism, Oppression, and Hate in London" is aligned with the priorities of both the Province and the City of London to create inclusive communities, and to identify, address and prevent racism, hate, discrimination, and oppression.

In early May 2023, the City of London was notified that its proposal was successful. In June 2023, an announcement was made regarding the receipt of \$500,000 to carry out the two-year pilot project.

2.3 Overview of the Project

The project consists of the following activities:

- 1. Establish an external centralized website where resources, videos, and bystander tips related to anti-hate will be hosted and shared.
 - The portal will include a library of existing resources and scalable tools as well as new resources to address any existing gaps; and,
 - The portal will be created through collaboration and outreach with relevant community partners and existing initiatives across the community.

2. Develop a local anti-hate public awareness campaign.

- The City of London will develop an anti-hate campaign that will include the use of billboards, social media, print, and online platforms, with the use of consistent messaging and a shared approach;
- The City of London, with the support of the Ministry and a local steering committee, will be responsible for creating the promotional materials.
 Individual dissemination and customization of this material and the associated costs would be the responsibility of each community partner involved:
- The campaign will be promoted by community partners, service providers, and the London & Middlesex Local Immigration Partnership.
- The campaign will include referrals to the project website, and will focus on increasing knowledge, awareness, and education on hate and discrimination as well as local efforts to address it; and,
- The campaign will effectively address the intersectional identities of those who experience hate, including but not limited to; Indigenous, Black, Muslim, Racialized, 2SLGBTQIA+, those who have disabilities, immigrants and refugees, and other bodies that experience racism and oppression.

2.4 Progress to Date

The following actions have been undertaken with respect to the Anti-Hate Pilot Project:

- Hiring of a project coordinator to carry out the project work.
- Creation of a local Steering Committee: The committee consists of representatives of 14 institutional leaders and has met twice since January 2024. Representatives provide advice on the project, community connections and resources, and will share

project deliverables with their networks and the community.

- Northern Commerce Inc. was hired to develop the Anti-Hate project website as a subsite of london.ca.
- AdHOME Creative was hired to develop the marketing campaign; this includes the development of branding, logo, as well as campaign assets such as posters and billboards.
- The project coordinator has been meeting with community groups and organizations to discuss the current landscape of work happening in the community, gaps and ways to address them.
- Senomi Solutions Inc. was hired to carry out the evaluation of the project.

2.5 Next Steps

The following next steps will be taken with respect to the Anti-Hate Pilot Project:

- A budget of \$90,000 was allocated to contract community groups and organizations to develop community resources in alignment with project and community needs.
- In Fall of 2024, a public event will be held to launch the public awareness campaign and website.
- Focus group sessions with community organizations will take place in May to help determine content for the website.
- AdHOME will provide the final campaign concepts and branding for the website in consultation with project staff. The campaign and website will go live in September.
- The City of London communications team will work with the communications teams of all steering committee members to share all campaign communications.
- An evaluation will be carried out to assess the project's success and recommend next steps. This will include research, metrics development, and project evaluation.

Financial Impact and Considerations

The total cost of this initiative is \$500,000 over two years and is funded by the Minister of Citizenship and Multiculturalism and therefore there is no financial impact to the City of London. The funding agreement expires July 31, 2025.

Conclusion

The Anti-Hate Pilot Project complements and advances the work of the Corporation in addressing hate and racism and will provide a model for other communities. This pilot project will provide the City of London and community partners with tangible tools and resources for addressing hate and discrimination within our local community. In addition, any feedback gathered throughout this project will provide a path forward to better understand what actions ought to be taken to address hate and discrimination in London and can be a model for other municipalities.






2011 – 2021 Total London Population Change





Dear Colleagues,

I am writing to propose a motion for the implementation of a Fare Free Day for the general public, supported by the London Transit Commission on Sunday September 22 2024, to coincide with Car Free Day. This initiative aims to provide an opportunity for the community to experience the benefits of public transportation without the financial barrier of purchasing a fare. I have spoken with leadership at the London Transit Commission and they've indicated they would be supportive of this initiative if there was funding available.

There is currently a group of volunteers who are organising a variety of initiatives for Car Free Day in London for Sept 22, 2024. This includes cycling and pedestrian events, promotion of the event, and other events across the city. The cost for a fare-free day on a Sunday is currently \$17,000 and I am seeking support from Council to allocate one-time funding for this initiative from a reserve fund. Benefits include;

- **Community Engagement:** A fare free day can serve as a platform to engage the community and encourage dialogue about the importance of public transportation.
- Promotion of Transit Use: Offering a fare-free day can serve as a promotional tool to attract new riders and increase awareness of the benefits of public transportation. Once individuals experience the convenience and cost-saving benefits of transit, they may be more inclined to use it regularly.
- Achieving CEAP Mode Share Targets: To reach these goals, a shift from current levels of car use to transit is needed. A Fare-Free Day on Car Free Day provides a great opportunity for the City to help residents try a new method of transit. Implementing a fare-free day demonstrates Council's commitment to serving the community and promoting sustainable transportation options.

In light of these benefits, I would like Council to consider implementing a fare-free day for London.

Drafted Motion:

Motion to DIRECT Civic Administration to allocate \$17,000 from the Community Investment Reserve Fund to provide funding to the London Transit Commission to offer a Fare Free Day on Sunday September 22nd 2024, in alignment with the international Car Free Day event and to encourage Londoners to choose sustainable transportation options.

Your worship Mayor Morgan, and all Councillors as members of the SPPC:

Three days ago on April 23rd, London reached the fifth anniversary of London City Council's Climate Emergency Declaration. There were seven motivating observations, including the following: "Whereas recent international research has indicated a need for massive reduction in carbon emissions in the next 11 years to avoid further and devastating economic, ecological, and societal loss..."

In response, the City set up a Climate Emergency Action Plan (CEAP) to respond to its Declaration, which it called "a fundamental and required response". The very first of CEAP's three stated goals is "Net-zero community greenhouse gas (GHG) emissions by 2050"; it also calls for a 55% reduction below 2005 levels by 2030. These challenging undertakings require a massive and ongoing response by the City administration, our corporations, and the community. They are also what motivates our Working Group.

Just this month, the City set itself Mode Share Targets seeing a reduction by 2050 in personal car use from 61% to 52.5% of trips taken, and an increase from 23% to 32.5% in the number of trips taken by transit or active transportation. What recurring occasions present themselves for the City to engage Londoners about this task it has set for itself?

International Car Free Day (CFD), held annually on September 22nd, has been around for thirty years. In 2000, the European Union adopted it as a European initiative. The UN Environment Program observes that "The event (Car Free Day) highlights the numerous benefits of going car-free to citizens...". We suggest that Car Free Day is an ideal time, annually and publicly, for the City and Londoners to take stock of where we are at on the road towards the Mode Share Targets.

Our Working Group has taken upon itself the task of enabling an ambitious Car Free Day by working with partners interested in a better environment and better health for the population. We hope that the City will journey with us on that day. In London, we will be highlighting two alternatives to personal car use on CFD: increased active transportation, and transit use. We foresee facilitated bicycle rides along the Thames Valley Parkway's three branches, and a festival in Wortley Village. Regarding transit, we envisage a Fare-free Day on London Transit buses on Sunday September 22nd, to provide, among other things, the chance for Londoners to use their transit service for free on Car Free Day, on a Sunday when most people have the time to try it out.

We are motivated by concern for the recent state of the environment in Canada, which has seen floods, extreme weather such as high winds bringing down trees and causing damage to infrastructure, and in particular a fundamental shift in the level of fire activity in our nation. (We note in passing that last year saw the previously-unimaginable amount of 18.6 million hectares burned, representing 5% of the forest cover in Canada. This devastation represents over 250% of the previous **record** level over the preceding 40 years of 7.1 million hectares burned in one year.) We believe that many, if not most, Londoners feel the need to respond to this environmental situation in some way.

Our efforts to enable an engaging Car Free Day on September 22nd will provide just such an opportunity for the City and its citizens to respond. We ask the city to partner with us by covering the anticipated \$17,000 cost of providing a Fare-free Day on its London Transit service, as proposed by Ward 11 Councillor Skylar Franke. We see this as a measured investment towards achieving the City's own GHG reduction goals.

I am writing on behalf of the London Environmental Network (LEN) to share our support for the proposed motion of an LTC Fare Free Day, to celebrate World Car Free Day on September 22, 2024.

The LEN has been a long-time advocate of active transportation as a way to reduce London's emissions and create a sustainable city. We promote active transportation events and member organizations year-round. Specific examples include promoting and participating in London's Mobility Master Plan feedback surveys and hosting an annual transportation-focused employee engagement challenge ("Green Wheel") for local businesses in our Green Economy London program. Our organization has several measures to encourage active transportation among our staff, including bus pass reimbursement and becoming a member of London Cycle Link's <u>Bike Friendly Business program</u>.

The local volunteer group's plan for a free transit day would be a huge draw for Londoners to participate in the day more effectively. We've seen previous examples of thousands of Londoners coming together to make an impact, from climate action marches to litter clean-ups. When people see their friends, coworkers, and neighbours participate in a local movement, it inspires and encourages them to get involved too. This day may introduce a whole group of people to public transit and encourage them to use this service regularly.

The car-free working group's plans are sure to make it a memorable one for London. David Stanford recently contacted LEN about his ideas and desire to get a volunteer group going. As a network, nothing is more exciting than seeing more community members step up and take action in the city! LEN is thrilled to support these initiatives and participate in World Car Free Day.

A Fare Free Day is a great follow-up action for London's new mode share targets. It's also a great example of the Climate Emergency Action Plan (CEAP) in full force: it is a community-led action backed by the City that will create city-wide benefits. It would also be a great milestone for London, showcasing London as an example of what equitable and sustainable transportation initiatives can look like.

The LEN wholeheartedly supports the motion proposed by Councillor Franke for a Fare Free Day on September 22nd. We hope to see City Council support this motion to provide all Londoners with the opportunity to participate in World Car Free Day this year.

Changing behaviour is hard. People often need an incentive, or to be pulled by necessity.

For me, trying something new is best done when I am not under time pressure. Therefore, providing an opportunity to travel by transit on a Sunday makes sense. It is also, I imagine, the day with the least ridership, and therefore the least expensive day to offer this. Car free day is a worldwide event, happening every September 22 – and there will not be another year that Car Free Day falls on a Sunday for many years. If we delay until another year, it will be more expensive to do since it will fall on a weekday. Other reasons to support this motion include:

- This lines up with the high school pilot at Clarke Road starting in September. There will be more talk in the community about taking transit so this is good timing.
- We are not asking people to ditch their cars, but to be strategic about when they could
 use transit, like going downtown on a Sunday where you are encouraged to walk around
 and explore, not just drive in and out to do a quick pick-up/take-away.
- In today's climate, affordability is a top priority for many people. "Risking" money on transit can seem like an unaffordable expense. Offering that people could ride for free for a day to test it out would remove that barrier.
- We know we need to improve our mode share targets in order to meet our climate targets, and we need to try some new strategies.

Once you have tried something new, it feels more comfortable. Many people cannot imagine wanting to travel without their cars. But sometimes, when you are put in a new situation (like when we travel to other cities), we are more open to trying transit. This proposal might do well to partner with Tourism London to invite Londoners to "explore London as a tourist" and hop-on/hop-off London Transit for a day.

London Greens favour the creation of sustainable cities, focused on strong, connected communities that permit residents to move quickly and easily to work, school and leisure activities. Public transportation forms a large part of that vision. We ask that the City partner with the Working Group for Car Free Day 2024 to cover the projected cost of \$17,000 to provide a Farefree Day on its London Transit service, as proposed by Ward 11 Councillor Skylar Franke. This action aligns with the City's stated CEAP goals and offers tremendous opportunities for community engagement and education. We have seen the enormous success of London's Clean and Green activities in April, bringing out neighbourhoods, businesses, community groups etc to beautify the city through numerous clean ups. We believe that Car Free Day has the same potential to capture the imagination of London's citizens and get them excited about leaving their cars at home.

For approximately thirty years, International Car Free Day (CFD) has taken place on September 22nd, encouraging people to leave their cars at home. It highlights the health benefits of active transportation, the sense of connectedness to one's community, and the environmental gains through decreased pollution. This year, the City could use Car Free Day 2024 to promote its recent Mode Share Targets and get Londoners onto buses, many for the first time, thereby fulfilling one of its CEAP goals to "bring everyone along".

Two years ago, City Council unanimously approved a Climate Emergency Action Plan, meant to guide the City in its decision-making processes to ensure that policies, development plans, and other actions reflect the urgency of climate change and its negative impacts on our City and communities. Two of the stated goals include achieving net-zero greenhouse gas emissions by 2050 and "bringing everyone along". A key means by which to reduce GHG emissions is limiting personal vehicle use and encouraging alternate modes of transportation. At the moment, we still struggle to get Londoners onboard with leaving their cars at home and choosing active or public transportation. For many, the greatest hurdle is lack of familiarity with alternate options. Car Free Day is the ideal opportunity to introduce Londoners to London Transit.

One Fare-free Day, familiarizing Londoners with their local transit service, could see ridership increase in the future. The City could see a significant economic return on this \$17,000 investment, and even greater environmental and social returns.

Hello SPPC,

I am writing to you today to request Delegate Status on Item 4.1 at the upcoming SPPC meeting on May 7th, 2024, in regards to Fare-free/Car-free Day. I also wish to share my full thoughts on this motion put together by Councillor Franke not only to expand on what my delegation would include, but also to give more context on where my perspective comes from. I will preface this with saying I absolutely respect & honour the intentions, perspective, & goal of Councillor Franke in putting forward this motion. I only wish to offer my perspective as a daily dependent user of the LTC system, and offer a counter-offer to her motion for fare elimination for Car-Free Day that I believe is a reasonable, win-win alternative for everyone with the same goal as Councillor Franke in mind.

The content of my presentation will be my perspective as a current LTC rider who has had no choice but to depend on LTC for the better part of the past 10 years. I plan to speak on the fact that though I respect/honour Councillor Franke's intentions & perspective & goal with the motion, there are several reasons why this won't be an initiative worth exploring, let alone would a permanent free fare policy be productive when it comes to our transit system. I will also offer an alternative option that may accomplish Councillor Franke's goal/intention, but also may help improve the system as a whole more than eliminating fares for one day or permanently would.

One major reason why this initiative, or her ideas for free fares, won't work is because our transit system isn't healthy or convenient or accessible enough to entice/incentivize people to leave their cars at home. Fares aren't the standalone barrier to why people are leaving their cars at home, contrary to many people's beliefs. This was only proven to be more after COVID, when fares were not collected and the revenue loss is still very much keeping us from having the healthy transit system that we should have had decades ago that would better incentivize/entice people to use it.

A second major reason why this initiative, and her idea of permanent fare elimination, will not work is due to the fact that these fares are paying for the improvements to make our transit system the level of appropriate convenience & accessibility in order to entice people to get out of their cars & use transit. Even as a low-income person myself, I have never asked for fares to be free ever, nor have I supported any efforts to do so.

That is because not only do I have 10 plus years of experience in understanding (even though not always agreeing) with how the funding streams work for improvements to our transit system, but I've seen first-hand, not only as a user, but as an observer, the "passing the buck" that has happened constantly onto the ridership when other levels of government, even after several efforts by Council & others to advocate for better funding for transit, don't fund it properly themselves.

Just recently, on top of that, I was one of the hundreds of riders/dependents of the transit system who had to deal with the 2nd increase (of 15-17%, for a total of 40% total fare increases since 2018) to our fares, and it wasn't entirely due to COVID either, but COVID certainly played a part. But what played a more massive part, and this is again working against making fares

free, is that post-secondary institutions have refused to pay their fair share (pun intended) of the fare increase, considering their students make up the majority of the revenue stream & ridership. They refused to pay more than 6% of an increase to their fare program (which self-subsidizes I might add, unlike the fare system for the rest of us) because "they don't see a value in the system". Which was really ironic in the recent TA strike when suddenly students were complaining about not being able to take transit to campus/class. But I digress....

The third reason neither this initiative for Car-Free Day, or permanent fare elimination will not work is due to the fact that LTC is already willingly forgoing revenue by allowing people to ride free everyday if they make enough of an excuse, and with discouraging their operators from enforcing their already-in-existence fare policy. I shudder to think how much revenue loss is coming from that daily, considering not many operators know how to use the keypad on the fare box to accurately keep count of people who don't pay fares, meaning an additional loss in revenue that the rest of us have to compensate for is not being tracked or included properly.

As someone who has had several interactions & opportunities to learn about the transit system itself, from how the farebox works to the function of each key on the keypad, I learned a lot about the keypad & the importance of it. Presently, & historically, there is the "Insufficient fare" option on the keypad on the fare box, which is what should be pressed everytime someone either don't pay their entire fare, or their card doesn't work (which is still a HUGE issue across fare cards) to people refusing to pay. This would be a greater opportunity to not only discourage drivers from confronting/refusing service to people, but would also more accurately track the lost revenue that comes from it. I don't see many drivers using this keypad, nor do many new drivers even know about it in the first place.

Those of us, not only of low-income, but those who are also in the disabled community, who depend on the service out of no other option or due to not having the privilege of having another option, have already borne the brunt of the costs to improve our system as is, with little to no return on that investment & constant hit on our own finances. Due to either lack of government funding, or COVID revenue loss, to current daily revenue loss, to the fact that post-secondary students don't pay their fair share of any increases due to, quite frankly, a disgusting sense of entitlement & ignorance of their responsibility as users to share in the impact of fare increases, (and LTC having refused to take these post-secondary institutions to a referendum when they objected to paying their actual fair share, I might also add, which is a whole other can of worms by itself) so to not only have a fare-free day initiative, but also in the future present a permanent fare elimination, does nothing to actually improve the system for anyone, and the revenue loss will need to be recouped somehow. And if riders aren't going to be expected to pay fares, then that will mean improvements to the system will probably be on the chopping block, which is entirely opposite of Councillor Franke's clear goal.

I personally invite any councillor to give up their cars for a day & take a day to travel by bus with me in order to demonstrate just how unhealthy our current transit system is, & has been for several years, if not decades. Unfortunately, it may be a little more costly for any councillor, as cash fare for what will be multiple trips that will exceed a 90 minute transfer makes it very cost-ineffective for anyone who doesn't have a transit pass or stored value card or tickets or what have you.

Which of course would be much easier if our transit system offered a day pass instead of needing 3.50 every round trip. That in itself would be a great compromise for Car-Free Day & going forward if Councillor Franke wishes to entice/encourage people to leave their cars at home, not only on Car-Free Day, but on any day where they only need to make trips to and from somewhere, and maybe even a broader incentive for visitors as well. Other municipalities have it, and it allows unlimited trips on their transit system for the entire day, which is more cost-effective by itself than using tickets or cash fares or a monthly or weekly pass. The idea has been presented in the past, but LTC decided against implementing it several times when it's been presented by even former Chair of the Commission & other Commission members.

Which I have always found strange, as I think not only would it benefit users, but it would also benefit LTC as it would be an additional source of revenue towards improving the system to

being more of a healthy enough system to further entice people to get out of their cars or leave them at home. Maybe a day pass can finally be an option presented through this motion as a compromise.

I hope that in this letter, & in the delegation if it is granted, that I make a very clear case for while I support the intention/goal of Councillor Franke, the system, & the funding, as it is set up now does not help towards that goal of enticing people to take transit on not only Car-Free Day, but also permanently by eliminating fares. And I hope offering an alternative/compromise, that perhaps we could see the overall goal/intention of Councillor Franke realized.

I thank the Committee for your time and attention to this matter.

To whom it may concern,

I am writing with respect to item 4.1 "Request for Implementation of a Fare Free Day - Councillor S. Franke" on the agenda for the upcoming meeting of the Strategic Priorities and Policy Committee on May 7, 2024. Please note that I provide consent for this submission to appear on the public added agenda.

I urge London City Council to support the request from Councillor Franke to allocate \$17,000 from the Community Investment Reserve Fund to provide funding to the London Transit Commission to offer a Fare Free Day on Sunday September 22nd 2024, in alignment with the international Car Free Day event and to encourage Londoners to choose sustainable transportation options.

Enabling the public to use transit and active transportation is paramount to fulfilling several areas of focus in the 2023-2027 Strategic Plan, including Mobility and Transportation, Economic Growth, Culture, and Prosperity, Climate Action and Sustainable Growth and Reconciliation, Equity, Accessibility, and Inclusion.

It is no secret that London is experiencing myriad challenges with transportation. While this one-time investment will not alleviate these challenges, it will have several positive effects on our City and create value that far exceeds the cost. Ultimately, this is about shifting behaviour and getting more people to care enough to try something new. It is an opportunity for the City to demonstrate its commitment to mobility and celebrate its transportation investments made to date.

There are indeed many Londoners who already depend on public transit for their daily transportation needs. There some who will likely never use public transit for various reasons. Then there is a large proportion of the general public who are open to being persuaded to use transit more regularly and depend on personal vehicles less. I believe the subsidy of public transit fares on Car Free Day, and accompanying promotions by the City and its partners, are an effective way to engage this target audience.

The City has carried out extensive research on transportation needs as part of the development of the Mobility Master Plan. From my personal point of view as a student and specialist in community engagement in climate action, I perceive that a lack of familiarity with transportation alternatives is a key barrier for many Londoners. Despite extensive ongoing communication efforts by the City, many Londoners still don't know about how to get around on bus or bike; they are less likely to be familiar with new transit routes and cycling infrastructure, leading to hesitation and defaulting to using a car because of its perceived convenience and familiarity.

How can we get more people familiarized with the LTC's services and actually taking the bus? First they need to go through the motions and try it, even just once. A simple way to facilitate this is by dedicating a day to positively reinforcing public transit and removing cost as a barrier to entry. While subsidizing a \$3.50 fare for one day might seem trivial, for many Londoners taking the bus to and from their destination on Car Free day, saving \$7

could impact how much they're available to spend on supporting a local business. For instance, a family of five people taking the bus together instead of driving could save \$35.

People respond positively to communications when there's something tangible in it for them, like a giveaway or a limited-time offer. In this case, they're being granted an opportunity through free bus service to maybe try a new experience and participate in a social movement larger than themselves, reflecting a priority of their community to share access to better ways to move around. If the City wants residents to give something – namely, to try changing up their commute – then investing in a fare subsidy is symbolically important as the City gives them something back in return.

Personally, if this plan goes ahead and transit fares are subsidized on Car Free Day, I'm looking forward to visiting the downtown core to browse goods at Covent Garden, check out the progress being made at Harris Park and dine at a local restaurant. The money I will save on transit that day will be fed right back into the local economy. I'll be able to proudly share on social media that the City where I live is celebrating public transit by inviting more residents to get on board.

My parents were immigrants from Europe after the war and I have seen first hand how immigrants have come and become industrious and important parts of our society and economy. One friend who came over a decade ago and still struggles with PTSD is now working in a window factory, paying his taxes, saving for a house. I began helping him

with language training and resume preparation. He also has become an incredible artists doing commissions of pets and any other work that he is inspired to do. His world is small in Canada, but his art touches hundreds of people each year.

I worked on the AIDS information line and Gay Line. It is a long time ago and, to my knowledge, only the director of the organization (at the time) and I are alive today. So many people lived in fear for their lives... and, back then, concerns for their safety was legitimate. I remember being part of a team walking people to their cars, we required 2 team members because it wasn't safe for one person to walk back from the parking lot to the community centre. Beatings were a sport for some.

It is so important to foster a culture of inclusion and acceptance. Women, Indigenous people, People living with mental health problems... we are all part of our society.

I grew up mostly on family farms ranging including eggs, pigs, dairy and cattle. We have owned a farm and have cashed cropped for decades. I have some sense of the importance of agriculture and the challenges farmers face.

In addition I worked for my father's commercial contracting and development companies before I went into a carrier in tech. My siblings continued to operate commercial holdings and are currently exploring developing a small property outside the Conservation Authorities watershed.

I've worked with financial documents for numerous private and public organizations and contributed to boards and committees in that environment. I also bring my experience during my short time on the board of the LTVCA.

I have a strong tech background, developing business software, research and development and education. This brings a broad knowledge of technology and the scientific method.

The Code of Conduct for Members of Council ["Code"] is required under the accountability and transparency provisions of the *Municipal Act, 2001*. The current Code was adopted by Municipal Council in 2019. Although there have been minor housekeeping amendments in 2021, the Code has not been significantly reviewed or amended since adoption. As you are aware, Principles Integrity was appointed as our Integrity Commissioner in 2023, and one of the functions provided is consultation and advice regarding revisions to the Code. With the evolution of interactions with the public in recent years, it would be a good time to review the Code and consider any amendments that will help clarify scope and applicability; with an awareness that this oversight is funded by the taxpayers.

Accordingly, we are asking for your support for the following motion:

That the following actions be taken with respect to the Code of Conduct for Members of Council:

- a. the Civic Administration BE DIRECTED to undertake a review of the Code of Conduct for Members of Council and report back to a future meeting of the Strategic Priorities and Policy Committee, including the following components:
 - i. an environmental scan of codes of conduct for elected officials in comparable municipalities, with consideration of specific or general provisions related to "social media", email, and communications with the public;
 - ii. review of the Ombudsman Ontario "Codes of Conduct, Complaint & Inquiry Protocols and Appointing Integrity Commissioners: Guide for Municipalities" with consideration to limit the Code of Conduct for Members of Council to the four prescribed subject matters required pursuant to Regulation 55/18 of the *Municipal Act*, 2001; and
 - iii. review of the Code of Conduct for Members of Council using the Anti-Racism and Anti-Oppression Framework and Equity Tool, as required by the Policy for the Establishment and Maintenance of Council Policies.

Dear Colleagues,

As you are aware, existing municipal funding allocated to Ark Aid, a critical facility providing shelter and support to our homeless population, is set to expire imminently.

Recognizing the urgency of this situation, we ask City Council take immediate action to extend one-time funding in the amount of \$687,000 to Ark Aid for an additional 61 days (the end of July). This extension is crucial to provide stability and continuity of services while we work collaboratively to find long-term solutions.

We are also seeking your support to have staff engage with Ark Aid to review its most recent unsolicited funding proposal. It is imperative that this proposal is thoroughly assessed to ensure it is right-sized, refined, and aligned with our broader homelessness strategy.

By working closely with the proponents, we can ensure that the funding allocated is utilized effectively to maximize its impact on our community's most pressing needs.
