## Notice of Public Information Centre 3 Adelaide Street North / Canadian Pacific Railway Grade Separation Municipal Class Environmental Assessment Study



The City of London has retained WSP to complete a Municipal Class Environmental Assessment (EA) study for improvements to the Canadian Pacific Railway (CPR) crossing of Adelaide Street North. This project is being carried out under the planning and design process for a Schedule 'C' project as outlined in the Municipal Engineers Association *Municipal Class Environmental Assessment* (October 2000, as amended in 2015).

Adelaide Street North between Oxford Street East and Queens Avenue, including the

**CPR** crossing

Purpose of the Study:

The Transportation Development Charges Study (2014) and the London Transportation Master Plan (TMP, 2013) identified the need for a grade separation at the CPR crossing of Adelaide Street North. Currently, trains block the crossing up to 43 times throughout the day, leading to road blockages of up to 126 minutes per day.

Through this Class EA study, the City has considered a range of planning and design alternatives for the grade separation including underpass (rail over road) and overpass (road over rail) and has developed a preliminary design concept that recognizes all users including pedestrians, cyclists, rail, transit vehicles and motorists, and the community setting.

## Public Information Centre 3:

Three Public Information Centres (PICs) are held during this study. The first PIC was held on June 16, 2016 to review the study scope, existing conditions, need and justification and planning alternatives. PIC 2 was held December 14, 2016 to describe the multi-step design process, review the various design alternatives and obtain public

input with respect to urban design components. Since PIC 2 there has been additional technical investigation and review with respect to the design at the CPR crossing.

The purpose to PIC 3 is to present the Preliminary Preferred Design concept that takes into consideration the transportation and technical factors, property impacts, community interests, cultural heritage resources, CPR and public input.





#### **APPLICANT:**

City of London

#### LOCATION:

Old East Village - see attached map

#### PURPOSE AND EFFECT:

The need for an Old East Village Dundas Street Corridor Secondary Plan was identified through discussions on the implementation of the Bus Rapid Transit System. The east-west bus rapid transit route is proposed to run eastward from the Downtown along King Street onto Ontario Street and then eastward along Dundas Street within the study area (see attached Map).

The purpose of the Secondary Plan is to establish a long term vision for the area and guide the future character of development through more specific policies than those contained in the Rapid Transit and Urban Corridors Section of the London Plan. The Secondary Plan can also be used to implement a vision or design concept, specifically, an urban design framework to connect the King Street rapid transit corridor and the Old East Village business district to the north. The Plan will provide a framework for the evaluation of future planning applications and public and private investment in the area.

The first step in the process is the preparation of a Terms of Reference to guide the Secondary Plan process. A future public meeting will held to adopt the Secondary Plan.

#### POSSIBLE AMENDMENT:

The purpose of this meeting is to adopt a Terms of Reference for the Secondary Plan study. Future possible amendments to Sections 20.2 and 20.3 and Schedule D of the existing Official Plan and Policy 1565 and Map 7 of the London Plan to add the Old East Village Dundas Street Corridor Secondary Plan as a new Secondary Plan will be considered at a later date.



#### **AGENDA**

1. Top-Five Ask re: "Summary and Compilation of the Accessibility Advisory Committee's Open House Project."

The team reviewed the documentation and has put forward its top three categories, with actionable items under each. These items appear in the documentation below. We propose the following motion:

"Be it resolved that the following statement be forwarded and presented to CAPS, with the intent of receiving approval to move to council to undertake action on the priorities disclosed herein:

The Accessibility Advisory Committee asks for the following actions to be undertaken. These asks have been formed through a combination of community statements, lived experience, and historical reference, and galvanized by our five community open houses, wherein these three key areas of deficiency: Transit, Employment, and Infrastructure, were deemed to be of the highest priority and the greatest barriers to a fully inclusive community in London.

#### **TRANSIT**

The City of London, in order to provide an equitable accessible transit service, will commit to the following improvements:

- Reduction of wait time from three days to a maximum of one day
- Improvement of service call times to match call/wait/response times of that of the larger transit system
- Improve booking system to meet today's standards
- Increase of availability of accessible spaces on LTC busing or increasing paratransit rides
- Appropriate training and education of transit providers to assist in the respectful and appropriate interaction with people with disabilities, both visible and invisible.

The City of London has a vested interest, from a financial standpoint, in paratransit through its LTC commitments. As such, there can be no deflection of responsibility. An improved overall service would also align with mandates listed in AODA compliance, efforts to

increase employment access in the city, the London Plan, the various roadmaps to ending poverty, and a commitment to developing an age-friendly city.

#### **EMPLOYMENT**

City of London to be a leader in removing barriers currently preventing people with disabilities from becoming employed, by committing to the following:

- Removing artificial, non-job-essential requirements from all postings (CPR, driver's license, vehicle)
- Improving transit to ensure that people are able to get to interviews or jobs throughout the city
- Providing examples to the community of successfully employed PWD to provide visual representation for youth career aspirational goals
- Work with unions to remove systemic barriers to hiring people with disabilities (flexible hours, work from home, ergonomic issues, breaking up a full-time job into two part-time jobs)
- Working with community partners to improve awareness of accessible hiring best practices and tangible improvements to employment issues, including that the application process is fully accessible

#### And INFRASTRUCTURE

To promote a safe environment and foster equitable access to the community for all Londoners, ACCAC requests that the city:

- Improves notification of construction projects, blocked passages, and road work, bus
  route changes, and review the timing of pedestrian crossovers to ensure adequate
  opportunity for people of all ages and abilities to safely navigate through the city;
- Work with heritage departments to find a human-focused solution to promote accessibility in heritage-designated buildings
- Change snow removal minimums and prioritize pedestrian pathways and bus access points when it comes to snow removal.
- Commit to ensuring that all community gathering areas and parks under the City's mandate be fully accessible
- Ensure that City-funded housing programs live up to AODA-compliance metrics and that accessibility is a key component in the approval of development projects, both residential and commercial."

#### 2. Virtual meeting trial discussion

The committee engaged in a brief, albeit relatively informal, discussion about hosting virtual meetings.

The committee agreed that it may be easier to implement at a subcommittee level and will investigate opportunities to ensure that meeting areas have the facilities required to support these efforts.

What is needed is the following:

- · A facility with free and steady wifi
- An opportunity for participants to phone into a meeting
- A technological solution (whether it's a laptop or tablet), that allows for broadcasting

Jay has committed to investigating the opportunities that are available and presenting these at the next subcommittee meeting.

Dear Accessibility Advisory Committee:

I continue to experience accessibility issues with Paratransit and barriers continue to exist for myself and my roommates.

I provided an outline of my concerns on February 13, 2018 and my letter was forwarded to the LTC. I have attached their written response for your review. The letter states that several site reviews have been completed, however, a solution still has not been found and another site visit is highly unlikely to produce a solution.

The LTC and myself and my roommates are in agreement that the LTC is unable and unwilling to resolve the issue to restore the service that has been provided at our house under the same environmental condition for the past 28 years. Our house and street have not changed; LTC and Voyageur have previously indicated that service and vehicles have changed, which is preventing service to our home. Recently, this service has stopped or been provided sporadically and unpredictably.

Some drivers are refusing to drive down the road way, regardless of whether cars are parked in the laneway or not, and have more frequently insisted on picking up/dropping us off at the circle down the street instead of at our home. As I mentioned in my previous letter, this poses a severe health risk as my roommates are considered medically fragile with respiratory diseases that are susceptible to extreme weather. Additionally, wheelchairs are extremely difficult to maneuver through snow in the winter when the sidewalks and road have not been cleared. However, this would be mitigated with door to door service from Paratransit.

Again, this is a violation of our accessibility and human rights and we ask you and your committee to address the issue directly as the LTC is unwilling to resolve the issue with attention to our rights to a fully accessible community.

People in scooters can walk a distance with the aid of a Cane or a walker which is easily attached to their scooter. Well they are popping up your charges they are there for a half hour or an hour either in the food court or browsing through stores shopping in places they could not do it before because they would have only had the power to get there and not home again I can see this as nothing but a positive move if they put in five or six Outlets indoors for scooter charging.
