NOTICE OF COMPLETION

The City of London has completed a Municipal Class Environmental Assessment (MCEA) study to determine road improvements for Southdale Road West between Pine Valley Boulevard and Colonel Talbot Road, and Bostwick Road, north of Pack Road. This study was completed following the ‘Schedule C’ process of the Municipal Class Environmental Assessment (2000, as amended in 2007, 2011 and 2015).

The study determined Southdale Road West and Bostwick Road should be widened to accommodate all roadway users including vehicles, pedestrians and cyclists. Southdale Road West will be widened to provide two lanes of traffic in each direction, left turn lanes, sidewalks and in-boulevard bike paths on the north and south side of Southdale Road West. Initial improvements on Bostwick Road will include the addition of curbs and gutters, a centre median and sidewalks and bike paths on the east and west sides. In the future, and when warranted, Bostwick Road will have two lanes of traffic in each direction.

Southdale Road West intersection improvements include the addition of a two lane roundabout at Colonel Talbot Road. The Southdale Road West and Bostwick Road intersection will remain as a signalized intersection but will be upgraded to accommodate the road widening.

The preferred alignment and cross sections will be further developed during detailed design. Phase 1 of the project (Southdale Road West from Farnham Road/Bostwick Road to Pine Valley Boulevard) is scheduled for 2022. Phase 2, Southdale Road West and Colonel Talbot Road intersection improvements is anticipated in 2024.

An Environmental Study Report (ESR) has been prepared and will be placed on public record on April 25 to May 27, 2019 for thirty (30) calendar days to be reviewed by members of the public and/or any other interested party at the following locations:

The City of London is undertaking a Municipal Class Environmental Assessment (EA) Study for the widening of Adelaide Street North according to the recommendations in the City's *Smart Moves Transportation Master Plan* (TMP). The study area includes Adelaide Street North from Fanshawe Park Road East to 350m north of Sunningdale Road East; including Sunningdale Road East from Blackwater Road to Stoney Creek Community Centre entrance. This project is being carried out under the planning and design process for a Schedule C project as outlined in the Municipal Engineers Association's *Municipal Class Environmental Assessment (October 2000, as amended in 2007, 2011 and 2015)*.

Public consultation is a key element of the EA planning process, and the second Public Information Centre (PIC) to share study details with the public is scheduled for:

The PIC will be held as a drop-in format, where attendees can freely browse the display boards, which will be used to present and obtain feedback on:

- The alternative design concepts and evaluation criteria;
- The preliminary preferred alternative design concept; and,
- Potential impacts and mitigation measures.

Following the PIC, in consideration of the comments received, the project team will confirm the preferred alternative design concept. Afterwards, an Environmental Study Report (ESR), which documents the EA process undertaken, will be compiled and made available for 30-day public review.

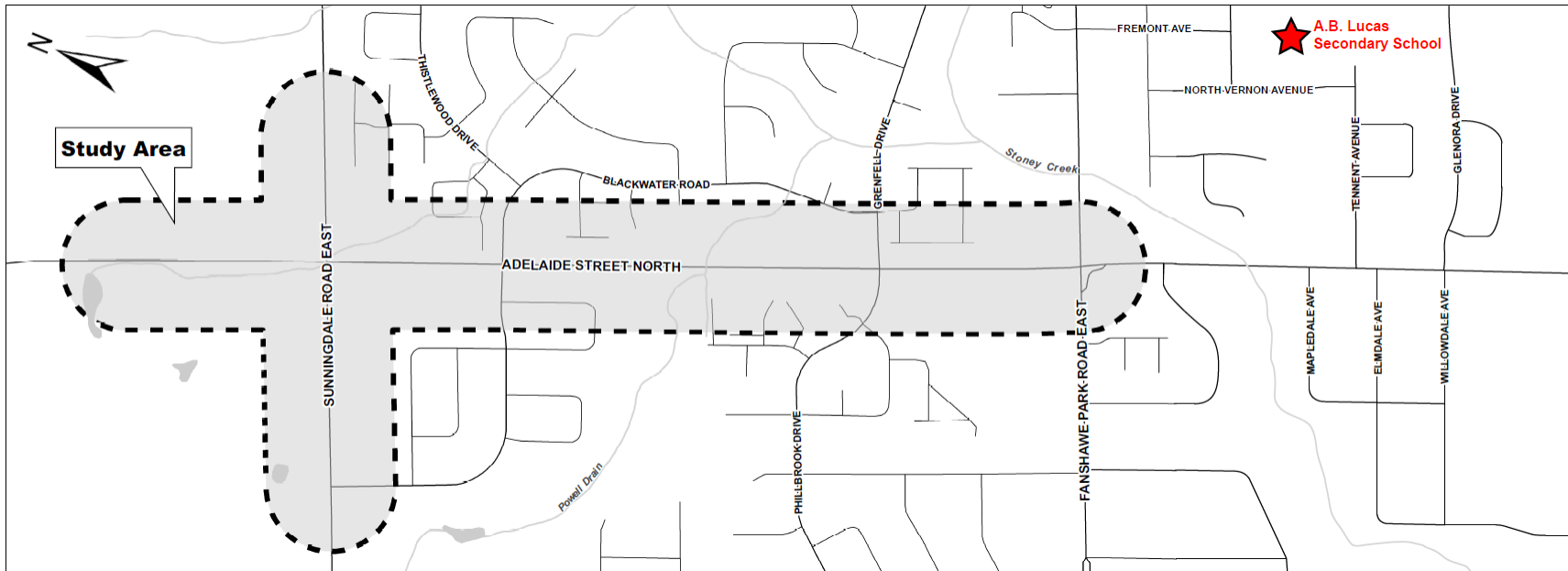

NOTICE OF PUBLIC INFORMATION CENTRE #1

The Study

The City of London is completing a Municipal Class Environmental Assessment (EA) study to determine road improvements for Dingman Drive, East of Wellington Road to Highway 401. This study will also address traffic capacity and road operational improvements to the associated Exeter Road/Wellington Road and Dingman Drive/White Oak Road intersections (Figure 1). This project was identified as a priority in response to the proposed London Gateway development (formerly PenEquity) near Wellington Road and Highway 401 and the corresponding increased traffic and pedestrian volumes. The proposed improvements will assess opportunities to improve existing cycling and pedestrian facilities connections to encourage active transportation.

The Process

The Municipal Class EA study will be completed in accordance with the Ontario Environmental Assessment Act and will fulfill the requirements of the *Municipal Class EA process (October 2000, as amended in 2007, 2011 and 2015)* for Schedule C projects. The project team will examine a full range of alternatives and identify a preferred strategy for addressing the project needs. The project will include public and agency consultation and require the completion of an Environmental Study Report (ESR).

Public Information Centre (PIC) #1

PIC No. 1 will be presented in an **online format** with material available **Monday June 17th 2019** on the City of London website at:

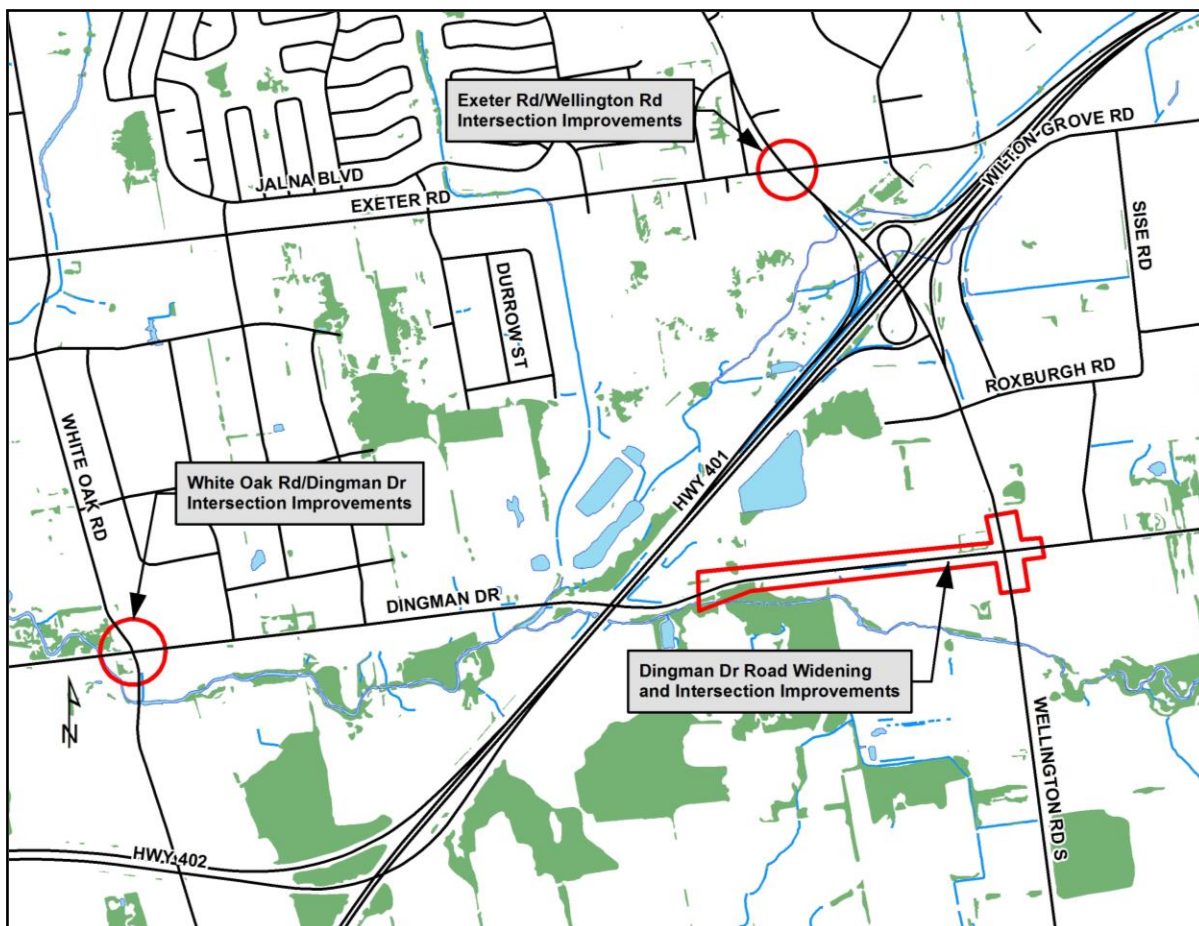
