Be my eyes – Pilot Project 2021-2022 Proposal

Challenges

- The pandemic has provided a host of new challenges to community engagement for people with disabilities. Fewer people out mean fewer opportunities to ask for assistance, and more difficulty with way-finding. As well, the barriers that have gone up to help with social distancing can be confusing and difficult to navigate. More signs than ever before are on display at businesses, etc... which only adds to this confusion
- Add to this additional physical barriers like construction, snow, road closures etc... and you start to get a picture of how difficult navigating in these conditions can be for people with various disabilities.

We've been investigating navigation apps to assist people to move around relatively independently throughout the City

We are piloting Blindsquare in Dundas Place. I presented this possibility to the Committee before the pandemic last year. Things were put on hold with the pandemic happening, but we are going to be piloting this shortly within that area. The area was chosen because of its lack of curbs and the fast-paced adjustments being made with changing structures/landscapes/patios due to COVID-19

However, we also got the chance to explore a new app, Be My Eyes. This technology will give us a broader opportunity to offer support and increase in navigating our City spaces

Be My Eyes

This is a free app that pairs people with vision loss or blindness with volunteers across North America. So, if someone is looking to pick out apples at a grocery store or choose a nice shirt, or read a sign etc... they are immediately paired with a volunteer who is sighted and can assist them. It's an effective app that is well-used and generally favourably rated. However, in terms of navigation in our community we needed something a little more significant to address more serious concerns like construction, snow, and community safety

Low Stakes Tasks = volunteers

Higher Stakes Tasks = trained staff

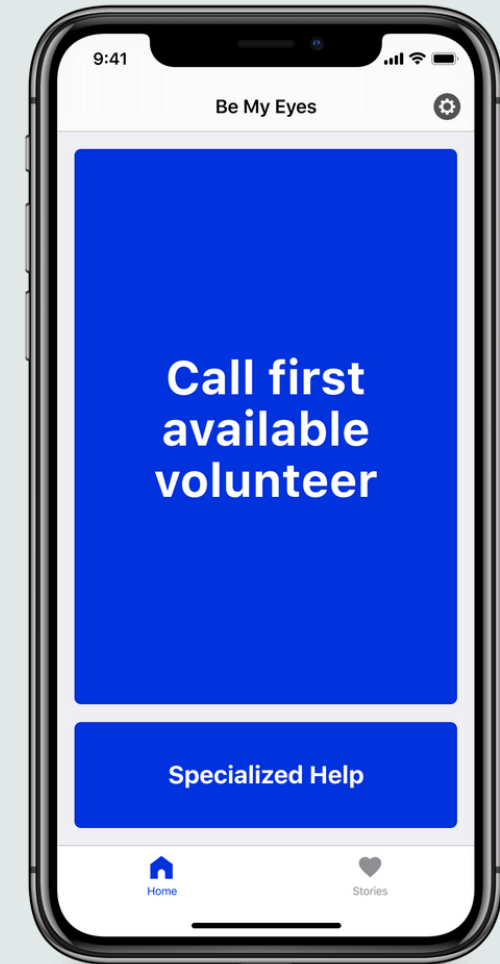


What Counts As High Stakes Tasks?

- We want to ensure that everyone who uses the Be My Eyes app in the City of London can get the help that they need. We recognize that some tasks need more specialized knowledge and training to be able to assist someone properly, and that is why we are proposing the institution of the Be My Eyes Specialized Service option
- High Stakes Tasks: finding a bus stop, navigating a construction zone
- Low Stakes Tasks: picking out a shirt, finding something in the house

City of London would have “specialized help option”

- Anyone in the City would be able to click on the specialized help tab and receive directions from a specialist at the Call Centre trained in orientation and mobility in both official languages
- The specialized help option is intended for high stakes tasks only!
- App is available for both IOS and android and it is free for users to install



CNIB & Be My Eyes Partnership



Be My Eyes - Volunteer

- User is connected to a volunteer somewhere in the world to provide basic sighted assistance
- Volunteers are not trained on how to provide proper guidance
- Free service for the blind and sight loss community

Be My Eyes – Specialized Service

User is connected to CNIB trained Agents

- Completed specialized Orientation & mobility (O&M) training
- Services provided in both official Canadian languages
- Confidentiality ensured via CNIB non-disclosure agreements
- Privacy ensured as no data is recorded or saved

User is connected to client Contact Centre

- Calls are routed to client's customer Contact Centre to provide sighted assistance

Be My Eyes – At Work

- Calls are connected to colleagues within the same company
- Colleagues offering sighted assistance can offer enhanced support as they have unique knowledge about the company and department.
 - Calls can be directed to specific departments
 - No data is collected or saved on BME servers
 - Data is transferred to Dashboard for evaluation

We're hoping to pilot the Be My Eyes Specialized Service this year

- The cost of this service and implementation is very reasonable and can be covered by our accessibility budget
- We would be the first municipality in Canada to have the app available, which gives us a competitive edge and could be good for growing businesses in the area
- Simple to use, and it may assist with some of our social and physical challenges in the City (construction, snow, finding bus stops, safety etc...)
- This project also aligns with our Safe Cities goals by allowing vulnerable people and women and girls to have someone to virtually walk with them as they navigate the city at night

How We All Benefit From Be My Eyes

- Be My Eyes is a useful tool for the blind and visually impaired, but if we implement it in London they won't be the only ones to benefit
- People with spatial navigation challenges will be able to use the service to check that they are at the right bus stop or are heading the right way
- Be My Eyes provides peace of mind and a set of eyes to watch over people walking alone at night, an especially useful service for the elderly and women
- It allows for seniors and those with vision loss or blindness to be more independent, which reduces stress on caregivers
- Volunteers can instruct seniors on how to complete simple online tasks or help them through smaller-scale technical issues like changing the input on the remote
- Short people or people who have dwarfism or identify as little people can use this service to see stuff that is above their line of sight, like if they are shopping
- And we know that there are many other ways to use this app! If we implement it, everyone in the community can benefit, not just people with disabilities

Next Steps

- Working with internal staff to ensure risk-management/contract issues are addressed prior to the pilot
- Ensure thoughtful and extensive communication (which is also accessible) between the various groups and stakeholders involved in this process
- Prepare an accessible feedback mechanism so we can study and address the impact of the pilot on the community

Mayor's New Year's Honour List Policy

Policy Name: Mayor's New Year's Honour List Policy

Legislative History: Adopted June 13, 2017 (By-law No. CPOL.-18-214); Amended April 24, 2018 (By-law No. CPOL.-18(a)-144); Amended July 24, 2018 (By-law No. CPOL.-18(b)-390); Amended October 15, 2019 (By-law No. CPOL.-18(c)-288)

Last Review Date: October 15, 2019

Service Area Lead: City Clerk

1. Policy Statement

- 1.1 This policy establishes the Mayor's New Year's Honour List for the recognition of persons who have contributed in an outstanding manner to the community of London in one of the categories of Accessibility, Age Friendly, Arts, Distinguished Londoner, Diversity and Race Relations, Environment, Heritage, Housing, Humanitarianism, Safety & Crime Prevention and Sports.

2. Definitions

- 2.1 Not applicable.

3. Applicability

- 3.1 This Council policy applies to all persons who have contributed in an outstanding manner to the community of London in prescribed categories.

4. The Policy

4.1 Categories

Persons may be recognized in any of the following categories:

- a) Accessibility (i.e. contributions to foster an environment of inclusion that embraces citizens of all abilities);
- b) Age Friendly (i.e. contributions to empowering older adults and advancing an age friendly community);
- c) Arts (i.e. contributions to fostering and/or the production of human creativity);
- d) Diversity and Race Relations (i.e. contributions to the elimination of hate and discrimination).
- e) Environment (i.e. contributions to the awareness, preservation and protection of the environment);
- f) Heritage (i.e. contributions to the awareness, preservation and protection of heritage resources);
- g) Housing (i.e. contributions to the provision of safe and accessible housing for all members of the community);
- h) Humanitarianism (i.e. contributions to human welfare through philanthropic and other efforts);

- i) Safety & Crime Prevention (i.e. contributions to a safe and secure community);
- j) Sports (i.e. contributions to the awareness of and participation in sports activity and/or demonstrated excellence within a particular sports activity);
or
- k) Distinguished Londoner (i.e., outstanding contribution to community collaboration or acts of good will by giving back to our City).

4.2 Nominating Committees/Organizations

The following Committees/Organizations shall nominate individuals in the respective categories:

- a) Accessibility – Accessibility Advisory Committee
- b) Age Friendly – Age Friendly London Network
- c) Arts – London Arts Council
- d) Diversity and Race Relations – Diversity, Inclusion and Anti-Oppression Advisory Committee
- e) Environment – Advisory Committee on the Environment
- f) Heritage – London Advisory Committee on Heritage
- g) Housing – London Housing Advisory Committee
- h) Humanitarianism – Diversity, Inclusion and Anti-Oppression Advisory Committee
- i) Safety & Crime Prevention – Community Safety and Crime Prevention Advisory Committee
- j) Sports – London Sports Council
- k) Distinguished Londoner – Each Council Member may submit one (1) name to the Mayor for consideration. The Mayor may select up to four (4) individuals for recommendation to Municipal Council.

4.3 Conditions

The following conditions shall apply to the nomination of individuals:

- a) a maximum of ten persons shall be named in any one year, with no more than one being from each of the ten categories referred to above subject to:
 - i) a person may not necessarily be named in each category each year;
 - ii) City Council may, at its sole discretion and on an exception basis, choose to recognize two individuals in any one category in a given year should the City Council determine that two individuals have inseparably partnered in contributing to their respective category, thereby increasing the aggregate amount of nominees beyond the usual maximum of ten persons to be named in any one year;
- b) the recipients shall be chosen for long standing contributions in their respective categories;
- c) the name of any one individual shall be included on the Honour List only once in their lifetime;

- d) any person currently serving as a member of any one of the Advisory Committees or organizations referred to in 4.2 shall not be eligible for naming to the list during their term of appointment;
- e) nominees being recommended by the Advisory Committees or organizations referred to in 4.2 shall have at least seventy-five percent of the total eligible votes on the respective Advisory Committee or organization.

4.4 Form of Recognition

- a) The recipients shall be honoured at the first meeting of City Council in January, with a reception for themselves and one guest, and presentation of an appropriately-worded certificate.
- b) A plaque shall be displayed in a prominent public area of City Hall honouring those persons named each year to the Mayor's New Year's Honour List and shall be updated annually by the City Clerk.

Re: Dundas Place Traffic Diversion Feedback

Introduction

One of our goals heading into the construction season this year was to improve safety for cyclists traveling through downtown, while maintaining access to local businesses for people traveling by car.

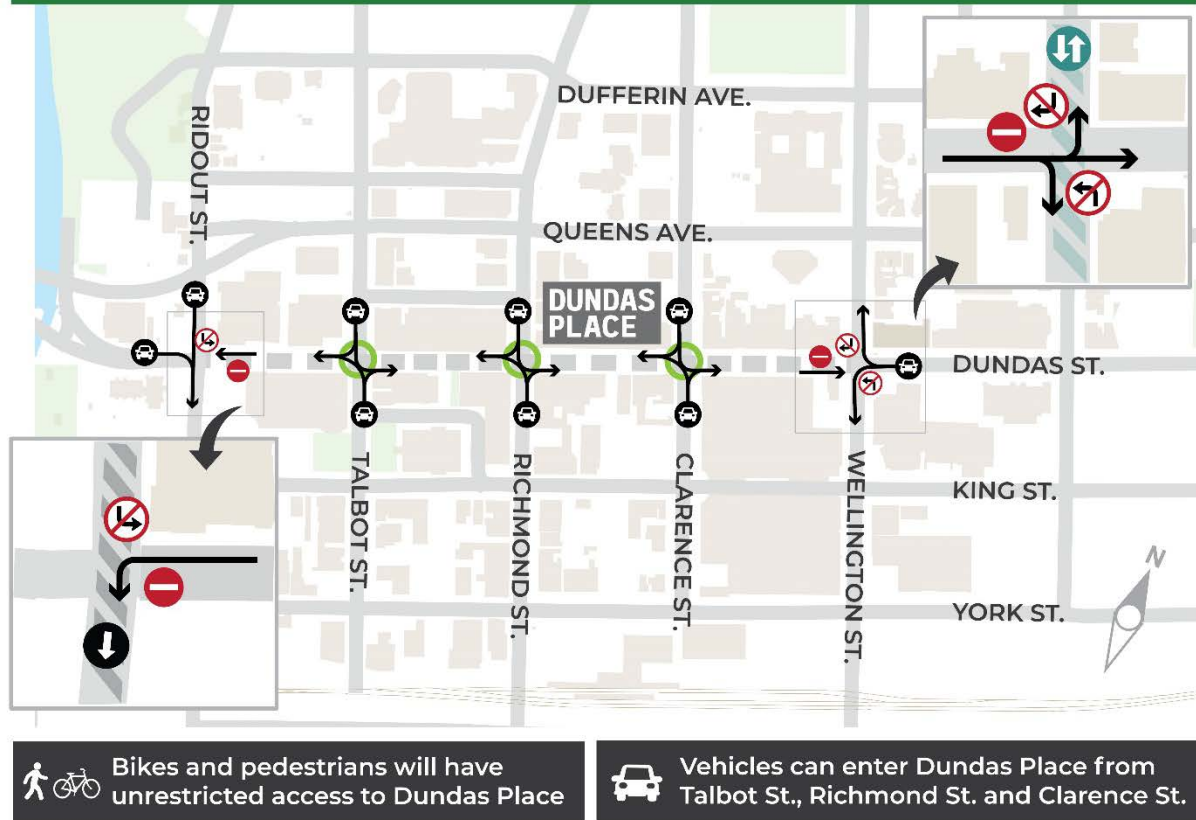
In early May 2021, the City made temporary changes to traffic operations on Dundas Place (the flex street portion of Dundas Street between Ridout Street and Wellington Street), to limit the volume of motor vehicle through-traffic and increase safety and mobility for all road users during the current construction season.

In this new arrangement, motor vehicles are restricted from entering Dundas Place at Ridout Street or Wellington Street. Instead, they have access to Dundas Place from Talbot, Richmond, and Clarence Streets to reach their destination. Vehicles are still able to exit Dundas Place at Ridout and Wellington Streets. The image below illustrates how this works.

Safety for vulnerable road users remains a priority, as well as supporting access to local businesses, and we're thinking ahead to what comes next for traffic operations on Dundas Place.

A Get Involved survey will be published for the general public's feedback soon and we would specifically like to hear from the committee their thoughts about the current traffic arrangement on Dundas Place. Providing feedback at or before the September Accessibility Advisory Committee meeting would meet our reporting timeline.

Project Restart

In January 2015, the City of London, through its consultant AECOM, initiated the Western Road and Sarnia Road/Philip Aziz Avenue Improvements Municipal Class Environmental Assessment (MCEA) for improvements to Western Road from Platts Lane to Huron University College and Sarnia Road/Philip Aziz Avenue from Coombs Avenue east to the Thames River (See Map). An initial Public Information Centre (PIC) was held in June 2015.

In 2016, the project was put on hold when alternatives for transit routes through the study area were being considered as they related to Rapid Transit (RT). As it is related to this project, the northern routes for RT have been deferred and the City has decided to restart this project.

Background

Western Road between Huron College and Platts Lane is part of a primary transportation corridor that services Western University and other local institutions in addition to some residential and commercial uses. Within this corridor, the Western Road and Sarnia Road/Philip Aziz Avenue intersection supports a large volume of vehicle traffic making turning movements, high pedestrian/cycling traffic and frequent transit services. This type of traffic is expected to increase in the future.

The City of London Transportation Master Plan suggests the Western Road and Sarnia Road/Philip Aziz Avenue intersection be improved to accommodate increased traffic, address safety, and improve road width constraints along Philip Aziz Avenue.

Planning for the Future

This study will be completed in accordance with the Ontario Environmental Assessment Act and will follow the MCEA (Schedule C) process. The project team will examine a full range of alternatives and improvements. Future university expansion plans, recent and or planned municipal infrastructure (e.g. watermains and stormwater management), walking and cycling features, effective movement of traffic and environmental impacts will be considered.

Your Involvement is Important

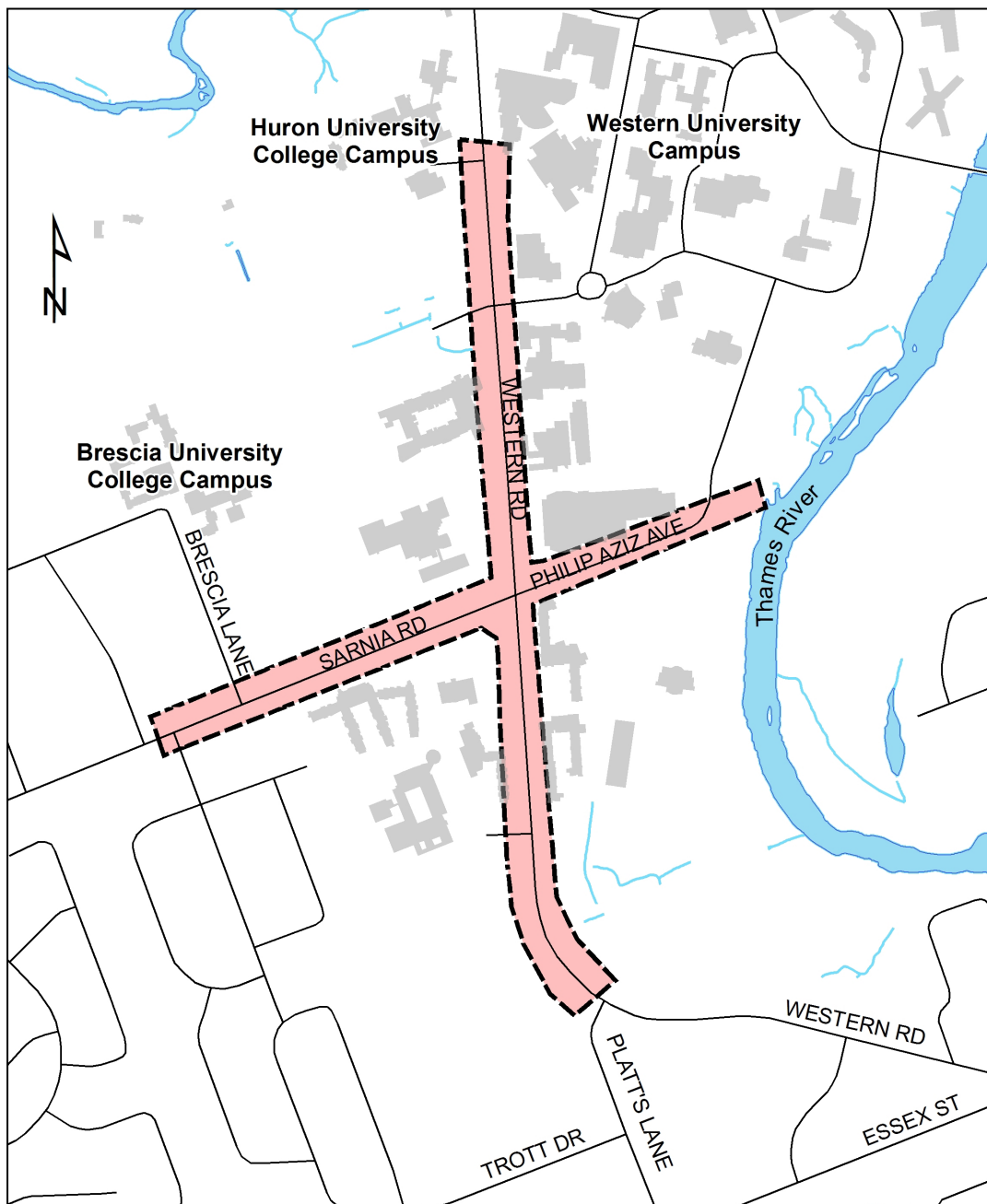

A PIC will be held in the fall of 2021 to present the updated problem/opportunity statement, a review of the study progress, the evaluation of the alternative solutions and project timeline. 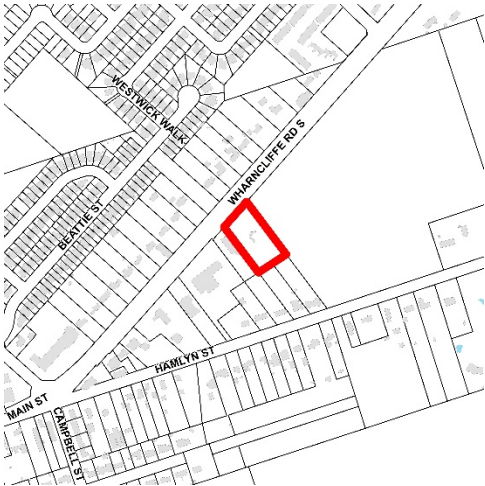

The subject lands are in the Neighbourhoods Place Type in *The London Plan*, permitting a range of residential and small-scale community facilities and mixed-use buildings.

The lands are also subject to the more specific policies of the Southwest Area Secondary Plan, which permits the primary permitted uses in the Auto-Oriented Commercial Corridor designation as the main permitted uses. The Southwest Area Secondary Plan policies prevail over the general Official Plan policies.

Right to Appeal to the Ontario Land Tribunal

If a person or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to the City of London in respect of the proposed plan of condominium before the approval authority gives or refuses to give approval to the draft plan of condominium, the person or public body is not entitled to appeal the decision of the Director, Planning & Development to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to the City of London in respect of the proposed plan of condominium before the approval authority gives or refuses to give approval to the draft plan of condominium, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

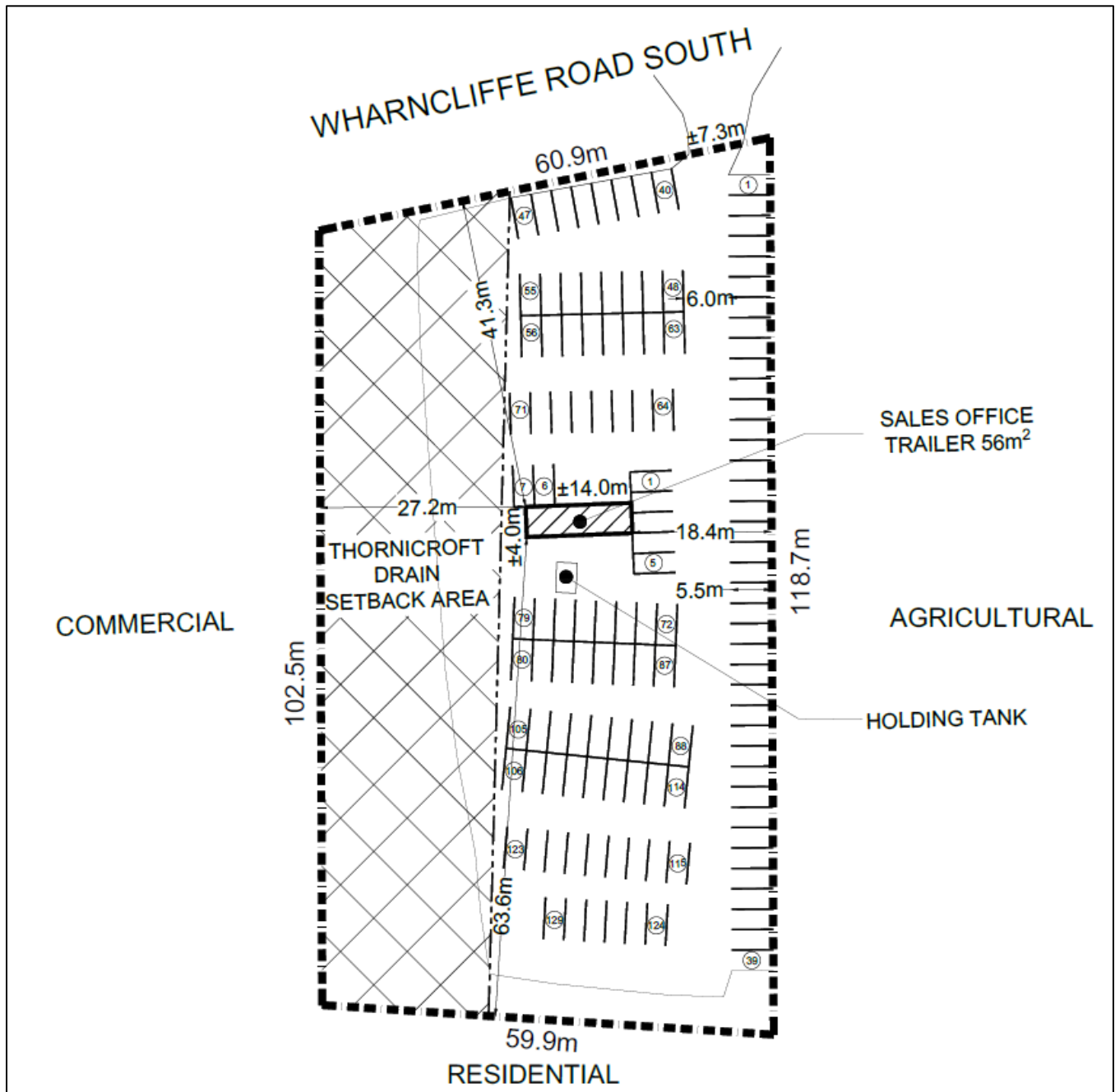
