I am passionate about our city, and believe strongly that living in a community means giving back when you are able. I believe in sustainable decision making by striking the right balance between finances, community life, and the environment - it is critical to a successful city. My experiences as a business owner, working with people experiencing poverty, and as a volunteer help me find that balance.

I have also run previously for this position: in 2018 I made a respectable showing while running against a popular incumbent, and in 2014 I placed a close third in a tight race of seven candidates. Investing all of this time, energy, and money into two campaigns means I know the ward and I know its key issues:

- Social impacts of addiction issues
- Relationship with Western campus
- Importance of green spaces, trees, and natural areas such as Medway Heritage Forest
- Making streets safer with traffic calming and appropriate bike/pedestrian infrastructure
- Access to efficient public transit from all corners of the ward
- Accessibility issues for people using mobility devices

It is a district of the city with a diversity of families, students, elders, and all walks of life. This is the kind of vibrancy a city needs to survive and thrive.

I have the backing of my family, my employer, and the residents of Ward 6 to take on this position. I would be honoured to represent the ward for the next year.

As an entrepreneur, I know the challenges and rewards of launching and sustaining a business. I have experience in responsibly managing both finances and time, as well as in building and maintaining relationships.

My commitment to our community solidified in 1999 when I began volunteering on Saturday mornings at the London Food Bank. Two years later, I started co-ordinating volunteers and, in 2016, joined the staff to run the Community Harvest program. In 20+ years of service, I have seen how many of our neighbours struggle to make ends meet. I continue to push for more supports for people experiencing poverty.

I am already familiar with City Hall, having served on the Advisory Committee on the Environment for the past nine years, including three terms as Chair. I also started serving on the London Advisory Committee on Heritage in 2019. Both of these committee positions have given me invaluable experience in working with staff and City Council. I work on the board of directors for ReForest London, the city's largest environmental non-profit organization. I started volunteering there in 2010, starting in tree planting before joining the board in 2015, and am currently the board secretary.

I am a past-president of the London Region branch of Architectural Conservancy Ontario, having served on the board since 2015. Heritage buildings need to be considered serious assets to a city, and also must be allowed to grow over time with sympathetic additions.

Please provide a brief written statement explaining why you would like to serve the remainder of the term as Ward 6 Councillor: (maximum 250 words):

I have been in Ward 6 for over 30 years. I come from the streets of this area. I have both gone to formerly Ryerson Public School, and now support the school as a volunteer while my children attend. I have befriended many ward residents through school events, neighbourhood functions, and book clubs. I know the families here and I hear daily about the things that matter to us most. Last week, my next-door neighbour came in and asked me if I had anything on my camera because her bike was stolen. I have previously worked at Western for 4 years in Financial Aid. I'm familiar with the administration and understand that Ward 6 must always include Western in the back of its mind when making any decision. Furthermore, both of my brothers live in Ward 6 off Lawson Rd. and I know many neighbours in that area. We want London to show, celebrate, and grow its diversity. We have gone through a major tragedy as a city through the terrorist attack of this past summer, which was specifically hard for my own religious community. Ward 6 holds the London Muslim Mosque (LMM). My grandfather was a builder of the mosque, my father was a builder of the school at the mosque, and when was on the BOD for the LMM, I built the extension and fought for federal funding for the elevator to ensure accessibility for all. I am both a product of and now advocate for the City of London's Muslim community, and the LMM. Appointing a member of my community would show good faith towards a marginalized group.

Please provide a brief written statement regarding your experience and qualifications: (maximum 250 words):

I worked for the House of Commons as an EA/Chief of Staff for Liberal MP Glen Pearson from 2006-2011. I sat with city council throughout that period, dealing both directly and indirectly with municipal issues involving the federal government. Secondly, I worked for the Syrian Coalition and Oppositional Forces - funded by the UN, EU and the US, in Turkey as the PR and Media Director for North America. I travelled the world meeting with foreign leaders and global media, advocating for and supporting the democracy movement in Syria. Through this project, I was a witness for Parliament of Canada's Foreign Affairs Committee to highlight the atrocities Syrian women were facing at the hands of both Syrian Government Forces and ISIS. Thirdly, I am a community-first person and have focussed on working hard to fix what was in my own backyard. I've chaired the London Public Library Board of Directors, and sat on a Striking Committee in 2011 for City Council. In 2015, I assisted the Mayor's office directly by settling refugees with the Syrian Refugee Fund, and by raising money and organizing support to help settle new Londoners.

In addition to these main reasons, I also have a great deal of Board experience (Regional HIV/AIDS Connection, Ontario Library Boards Association, Ontario Library Association, London Muslim Mosque, Scottish Rite Learning Centre, Association of London Muslims and many others), and have a Master's Degree in Library and Information Sciences.

(it being noted that Municipal Council cannot prevent a person who is eligible from seeking election to Municipal Council, regardless of the statement provided.)(maximum 250 words):

To begin, I would like to clarify that my family and I decided that whenever Phil Squire completed his time as the Ward 6 councillor, that I would then run for the vacant position in the next Municipal election to follow. I have always respected the work that Phil put forth in representing our ward and have been ready to step forward when his time came to an end. I respect that members of council feel that the Ward 6 appointment should not be allowed to run in 2022, but according to the Municipal Elections Act, this cannot be enforced and I agree with Western's Political Science Professor Andrew Sancton that incumbency "won't be a major factor" in the next election in his October 27 comments on AM980. I also feel that true democracy should not attempt to silence or inhibit the motives and opportunity for its participants to impact positive change at any time and for any reason, including placing restrictions on their right to run for publicly elected office. As mentioned, I do intend on running in the October 2022 Municipal Election. I believe in democracy very strongly and have engaged in the democratic process in Ottawa and in Syria. I fought hard for Londoners in Ottawa, and fought hard for the people of Syria and their right to democracy. As a proud Canadian Muslim woman living with a disability in Ward 6, I am ready to serve my community today, and as of this date am also ready to serve them in October 2022 if elected.

I'm a person with a disability, breaking down barriers and overcoming obstacles daily.

I believe the local Person with Disability community deserves a voice at council too. I developed PTSD after my work with the Syrian Coalition because of the severe trauma I experienced in a humanitarian role during the atrocities of the Syrian Civil War. I lost friends; witnessed, and reported UN Human Rights violations, and lived in a state of fear for my own life (my office in Turkey was bombed twice and targeted by of both the Assad Regime and ISIS). My PTSD played a role in my development of a disease called Fibromyalgia. This has led to massive weight loss and weight gain as well as mental health concerns because of the medications I've taken. I mention this only because I know that there is a stigma behind admitting that you have a disability or live with mental health challenges, and I'd like to destigmatize this idea and champion our right to be heard and to make a difference. My ability to show great empathy towards people because of my disability is what helps guide my policy decisions, which has been proven in my governance work with the Regional HIV/AIDS Connection, the Ontario Library Association and The London Public Library. Both of my children have dyslexia and other learning disabilities. This has opened my own eyes as a trained librarian to the importance of inclusion and accessibility for all voices and abilities. I have advocated on behalf of my children to local schools and libraries, because of my own struggles with finding materials to help my children learn.

Also, I didn't know if council wanted any reference letters, but my strength comes from my neighbours and friends I have made throughout the over 30 years in this neighbourhood. I can collect many references from Ward 6 residents as well as institutions inside the Ward as a strength of my candidacy.

My husband and I have a small business running a boutique commodities brokerage, and I have two daughters who are 10 and 13. The Hamou-Tsouli family is a proud Ward 6 family of Londoners, and I am a member of multiple diverse communities that deserve a voice at council. I hope that our council sees the value in deeming me worthy of temporary appointment to the vacant Ward 6 seat, as I am ready to do the work and contribute right away.
