- It would be helpful if parks staff could attend the AWAC re discussion.
- Audrey, if you can put up on screen, the AWAC formal written recommendation
 which contains the rationales regarding the importance of more consistently
 enhancing community awareness, wildlife safety, prevention strategies, intact
 canid families keystone ecological functions, with the goal of increasing
 successful co existence.
- Possible locates for signage re: parks "hotspots" where human activities such as chronic issues of dogs off leash, improper anthropogenic foods disposal, and wildlife feeding occur, that adversely impact human canid interface and increase complaints.
- Increased burden to City of London of not providing this vital element to Awareness Education, (one cornerstone), of the other key cornerstones, which include Prevention, Investigation, and Enforcement of Leash and Nuisance Feeding Bylaws.
