**Re:** Additional Compensation for Deputy Mayor, Committee and Board and Commission participation

Attached you will find for your review a high-level environmental scan to assist the Working Group in evaluating additional stipend and compensation options for Deputy Mayor and Committee, Board and Commission participation, in relation to item 3.6 of May 17, 2023 Governance Working Group Meeting Report.

It should be noted that the use of a per diem as remuneration for specific Committee roles (chair/member), working groups and board participation is not always available across the comparator group. Adopting new policies in relation to this approach would warrant further research from the City Clerk's Office if Committee considers it a viable option.
