I will bring my experience as an academic specializing in environmental philosophy and climate change, climate anxiety, and proactive climate adaptation to contribute to discussions about how best to help London negotiate the necessary transitions.

I am a relative newcomer to London who has lived and worked in several cities across North America and Europe previously. Before that, I was raised in a small rural community and have additionally lived with relatives in rural and agricultural communities. Before beginning graduate school in 2009, my work experience included restaurant work, construction and house painting, tutoring, ESL and office temp work, substitute teaching and child care.

These experiences brought me into contact with a wide range of perspectives and attitudes that are helpful in navigating the complexity of environmental questions and policies. In particular, spending time in my twenties working on my aunt and uncle's family ranch in rural Wyoming helped me better understand the impact of environmental policies on different communities. Additionally, working as an educator with recent immigrant communities (including Albuquerque, New Mexico, and New York City) and abroad (Central Europe) has given me experience in connecting with communities of different backgrounds and language skills. My experience as an educator now extends over twenty years and has included work with students as young as seven years old, immigrant adults, and university students.

Since arriving in London to take up a position in the Philosophy department at King's University College in fall 2020, I have taken an active role developing experiential environmental learning programs at King's. I am a founding part of the new King's Community Garden and a member of its Environment and Sustainability committee, with a goal of developing a formal institutional strategy for climate transition. I have

additionally made connections with Urban Roots, LOLA Bees (London Ontario Learning Apiary), Antler River Rally and Bird Friendly London. I am also part of the Community of Practice for educators working with the Indigenous Learning Bundles hosted by the Wampum Learning Lodge at Western University.

Prior to coming to King's, I worked and studied at three different universities (University of New Mexico, University of Oregon, Seattle University), serving on a variety of committees, task forces, and research groups. These experiences helped me learn about dynamics of group discussion and decision making and develop a basic pragmatic orientation that prioritizes listening, collective debate and discussion, and the importance of relationship building. I hope that my philosophical background, which is informed by a sense of the interconnections between the social, the ecological, and the mental, can contribute a creative and ethical perspective. A basic principle of this perspective is the importance of including and listening to a variety of diverse perspectives. I believe that because environmental issues affect all living beings, part of the work of climate action also involves building deeper relationships and learning how to dialogue across differences.
