## I YOUR COMMITTEE RECOMMENDS:

Moratorium on a Class of Pesticides – Neonicotinoids

- 1. (3,4,5) That the Civic Administration **BE REQUESTED** to postpone any recommendations on a neonicotinoids (a class of pesticide) seed treatment plan until the Ontario Ministry of Agriculture, Food and Rural Affairs, Ontario Bee Health Working Group recommendations are completed by the end of November 2013; it being noted that the Agricultural Advisory Committee (AAC) received the following with respect to this matter:
- a) a communication dated August 12, 2013, from G. Kenny, Program Coordinator, Emergency Response and International Development, the United Church of Canada, with respect to a moratorium on a class of pesticides called neonicotinoids;
- b) the <u>attached</u> presentation from T. Baute, Entomologist, Ontario Ministry of Agriculture, Food and Rural Affairs, with respect to a Working Group Study on neonicotinoids;
- c) the <u>attached</u> communication dated September 18, 2013, from M. Does, Food Not Lawns, with respect to links between the collapse of bee colonies and neonicotinoids; and,
- d) delegations from M. Knoester and C. Quinn, with respect to the use of neonicotinoids.
