I YOUR COMMITTEE RECOMMENDS:

ACCAC Conference Sub-Committee

- 1. (d) That the following actions be taken with respect to Accessibility Advisory Committee (ACCAC) Annual Empowerment and Action Day:
- a) the date of the 19th Annual Empowerment and Action Day **BE MOVED** to December 3, 2013, to correspond with the United Nations International Day for Persons with Disabilities;
- b) up to \$4,000.00 **BE APPROVED** from the ACCAC Budget to fund the 19th Annual Empowerment and Action Day; it being noted that the ACCAC has sufficient funds in its 2013 Budget for this expense;
- c) the Various Fees and Charges By-law **BE AMENDED** to reflect the Annual Empowerment and Action Day Conference registration fee to read "up to \$20.00";
