Recommendation

That, on the recommendation of the Deputy City Manager, Environment and Infrastructure, the following actions **BE TAKEN** with respect to the award of contract for rebuilding the incinerator at Greenway Wastewater Treatment Plant:

- a) The bid submitted by Lor-Don Limited at its tendered price of \$10,168,921.95, excluding HST, for the rebuild of the Greenway Incinerator **BE ACCEPTED**;
- b) the financing for this project **BE APPROVED** as set out in the Sources of Financing Report attached hereto as Appendix "A";
- c) the Civic Administration **BE AUTHORIZED** to undertake all the administrative acts that are necessary in connection with this project;
- d) the approval given, herein, **BE CONDITIONAL** upon the Corporation entering into a formal contract, or issuing a purchase order for the material to be supplied and the work to be done, relating to this project; and
- e) the Mayor and City Clerk **BE AUTHORIZED** to execute any contract or other documents, if required, to give effect to these recommendations.

Executive Summary

Incineration is the final process in the solids handling facility at Greenway, enabling the safe disposal of the waste solids generated at London's five wastewater treatment plants. Re-building the incinerator now will restore it for reliable service over the next 10 years, over which time new alternatives for solids disposal will also be developed and adopted.

This report recommends the award of a tender to Lor-Don Limited to undertake the rebuild of the incinerator at Greenway Wastewater Treatment Plant. The tender returned an irregular result because only one bidder submitted a tender. That single tender was from a pre-qualified contractor with good experience at Greenway WTP, and the cost was within budget and pre-tender estimates.

Analysis

2.0 Discussion and Considerations

2.1 Discussion

Greenway Wastewater Treatment Plant is the City's largest treatment plant. It is also the location of a centralized solids handling facility that processes the waste sludge removed from wastewater at all five City wastewater treatment plants in preparation for disposal. The final treatment process at Greenway is incineration, which takes the solids removed from wastewater through the treatment process and burns them at temperatures approaching 900 degrees Celsius. This reduces the solids to an inert ash that is ready for safe disposal.

The current incinerator and many associated parts were initially installed in 1986. By rebuilding the incinerator now, the intent is to provide reliable operation for the next 10 years. City staff are evaluating various potential strategies that will be put in place prior to the next end-of-life cycle.

2.2 Project and Procurement Description

The project involves demolishing the existing incinerator, rebuilding it in place, and replacing the key related infrastructure like ductwork, expansion joints and dampers.

The work is scheduled to take 180 working days to substantially complete and will start summer 2024. While the incinerator is out of service, solids disposal will need to be completed through the roster of venders previously approved by Council. Since costs of alternative solids disposal methods are higher than incineration, incentive and disincentive clauses have been built into the construction contract to ensure that the timeline is met or improved upon.

The procurement of a general contractor to complete the Greenway Incinerator rebuild was conducted as a two-part process, with prospective contractors first pre-qualified to bid based on their experience, expertise and capacity as determined by RFPQ-2023-270, which was published publicly on November 9, 2023. These pre-qualified contractors were then invited to submit tenders. Of the three firms who were pre-qualified, only one submitted a tender: Lor-Don Limited. The tender price of \$10,168,921.95, excluding HST, was within the pre-tender estimate and available budget. As per Section 13.2 of the Procurement of Goods and Services Policy, Committee and City Council must approve award of tenders greater than \$6,000,000.

Since there was only one compliant tender submitted, Section 19.4 of the Procurement of Goods and Services policy was applied. The decision was jointly made by the Senior Manager, Procurement and Supply and the Deputy City Manager, Environment and Infrastructure to open the single bid, which was subsequently found to be compliant and acceptable.

3.0 Financial Impact/Considerations

The detailed source of financing is included in Appendix 'A' of this report. Costs will be funded from existing capital accounts.

Conclusion

The re-build of the Greenway Incinerator is essential work that needs to be undertaken to ensure the continued effective disposal of waste solids from the wastewater treatment process. Lor-Don Limited submitted the only tender in a competitive process and is considered well-qualified to undertake the work required. Staff recommends that the contract be awarded on this basis.
