Recommendation

From:

That, on the recommendation of the City Clerk, the following actions be taken with respect to the appointment of Hearings Officers to conduct Hearings under various City of London by-laws:

- a) the proposed by-law as <u>attached</u> as Appendix "A" being "A by-law to approve the appointments of Hearings Officers in accordance with By-law A.-6653-121, as amended", **BE INTRODUCED** at the Municipal Council meeting to be held on June 25, 2024;
- b) the proposed by-law as <u>attached</u> as Appendix "B" to amend By-law No. CP-24 being "A by-law to provide standards for the maintenance and occupancy of property and to repeal By-law CP-16" to repeal Schedule "A" and amend s.7.2, **BE**INTRODUCED at the Municipal Council meeting to be held on June 25, 2024; and
- c) the Civic Administration **BE AUTHORIZED** to undertake all administrative acts that are necessary for these appointments.

Background

The Municipal Council, at its meeting held on April 18, 2011, enacted "A By-law to establish the positions of Hearings Officer" to hear appeals under various City by-laws and to approve the "Rules of Practice and Procedure for Hearings Before a Hearings Officer", pursuant to Section 23.1 of the *Municipal Act, 2001* and the *Statutory Powers Procedure Act*.

Further, at its meeting held on May 25, 2021, the Municipal Council enacted CP-24 "A by-law to provide standards for the maintenance and occupancy of property and to repeal By-law CP-16 being a by-law prescribing standards for the maintenance and occupancy of property". This by-law is commonly referred to as the Property Standards

<u>By-law</u>. This by-law updated Section 7: Establishment of a Committee, specifically related to:

- provision of the Property Standards Committee;
- appointment of Hearings Officers to the Property Standards Committee as a schedule to the by-law;
- forthwith fill for vacancy; and
- establishing administrative direction on remuneration, election of a chair, majority quorum, secretary role and maintenance of records, committee adoption of rules and procedures, and notice of hearing.

Discussion

Hearings Officers have been appointed by the Municipal Council and delegated the authority to hear appeals under various City by-laws. In most cases, a single Hearings Officer conducts the hearings and issues a final decision with reasons. Property Standards By-law appeals require a minimum of three Hearings Officers to hear the appeals and issue a final decision with reasons. With additional Hearings Officers, for efficiency, it is recommended that the By-law be amended to permit the committee to be organized into multiple panels, with a minimum of three officers per panel in accordance with the provisions of *Building Code Act*.

The Hearings Officers have been rotating the responsibilities for conducting hearings based on the availability of the individual. This has provided flexibility in setting hearing dates and has resulted in timely responses to appeals.

The <u>Hearings Officer By-law</u> requires Hearings Officers to be Canadian citizens and possess the following:

- knowledge and prior experience in administrative law;
- be of good character;
- · ability to carry out a fair and impartial hearing;
- ability to write a clear and concise decision;
- ability to communicate effectively with the public;
- an understanding of Statutory Powers Procedure Act; and,
- an understanding of the Municipal Act, 2001.

The Civic Administration has completed a targeted recruitment to seek additional qualified individuals to serve as Hearings Officers. Four individuals have expressed an interest in appointment and meet the qualifications as set out in the Hearings Officer Bylaw. These individuals have a record of community service and strong commitment to diversity and inclusion. The applicants have each submitted their qualifications, a summary of which are attached as Appendix "C" to this report for the information of the Municipal Council.

Conclusion

The Civic Administration is committed to providing flexibility and timely responses to appeals and is therefore recommending that the Municipal Council appoint Karen Hulan, Jack Huber, Leslie Ibouily, and Stephen Gibson as additional Hearings Officers to assist with the appeals workload and to serve on the Property Standards Committee.

Appendix "A" - By-law Appointing New Hearings Officers

By-law No.

A by-law to approve the appointments of Hearings Officers in accordance with By-law A.-6653-121, as amended, being "A by-law to establish the positions of Hearings Officer".

WHEREAS subsection 5(3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 23.2 of the *Municipal Act, 2001*, as amended permits a municipal Council to delegate its powers and duties to an individual who is an officer of the municipality;

AND WHEREAS the Council of The Corporation of the City of London enacted By-law No. A.-6653-121 being "A by-law to establish the positions of Hearings Officer" on April 18, 2011 and amended on June 26, 2018 and May 25, 2021;

AND WHEREAS the Council of The Corporation of the City of London wishes to appoint Stephen Gibson, Jack Huber, Karen Hulan, and Leslie Ibouily as Hearings Officers in accordance with By-law A.-6653-121, as amended, being "A by-law to establish the positions of Hearings Officer";

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. Stephen Gibson, Jack Huber, Karen Hulan, and Leslie Ibouily be hereby appointed as Hearings Officers in accordance with By-law A-.6653-121, as amended, being "A by-law to establish the positions of Hearings Officer".
- 2. This by-law comes into force and effect on the day it is passed subject to the provisions of PART VI.1 of the *Municipal Act, 2001.*

Appendix "B" - By-law to Amend CP-24 Property Standards By-law

Bill No. 2024

By-law No. CP-24-

A by-law to amend By-law No. CP-24, being "A by-law to provide standards for the maintenance and occupancy of property and to repeal By-law CP-16" to repeal Schedule "A" and amend s.7.2.

WHEREAS section 5(3) of the *Municipal Act, 2001*, S.O. 2001, C.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS the Official Plan for the City of London includes provisions relating to conditions of maintenance and occupancy of properties;

AND WHEREAS section 15.1 of the *Building Code Act* provides that the Council may pass a by-law with respect to prescribing standards for the maintenance and occupancy of property, and requiring property that does not conform with the standards to be repaired and maintained with the standards on the site to be cleared of all buildings, structures, debris or refuse and left in graded and levelled condition;

AND WHEREAS the Municipal Council on May 25, 2021, passed By-law No. CP-24, being "A by-law to provide standards for the maintenance and occupancy of property and to repeal By-law CP-16;"

AND WHEREAS the Municipal Council deems it appropriate to amend Bylaw No. CP-24 with respect to the appointments of Hearings Officers to the Property Standards Committee;

NOW THEREFORE the Municipal Council of The Corporation of the City of London hereby enacts as follows:

- 1. That Schedule "A" to By-law No. CP-24 be repealed.
- 2. That Section 7.2 of By-law No. CP-24 be amended in its entirety to read as follows: "The Committee may organize itself into panels of of no less than three persons to adjudicate matters. The Committee members appointed to the Committee are those Hearings Officers appointed by Council and Committee members shall remain in office at the pleasure of Council."
- 3. This by-law comes into force and effect on the day it is passed subject to the provisions of PART VI.1 of the *Municipal Act, 2001.*

Appendix "C"- Summary of Qualifications

Karen Hulan

Karen Hulan is a Partner with Beckett Personal Injury Lawyers in London. She has been practicing in the areas of personal injury and insurance law since 2003. In her practice, Karen represents clients in court and in provincial and federal tribunals.
