



NOTICE OF STUDY COMPLETION

Oxford Street West Improvements Municipal Class EA Westdel Bourne to Sanatorium Road

About This Study

The City of London has completed a Municipal Class Environmental Assessment (Class EA) study for improvements to Oxford Street West, from Westdel Bourne to Sanatorium Road (refer to key plan at the end of notice). The proposed improvements for Oxford Street West address future traffic capacity needs along the corridor and at intersections for all modes of transportation (pedestrians, cyclists, motorists) and users of all ages and abilities. The proposed improvements include:

- Widening Oxford Street West from two to four lanes to provide additional capacity;
- Intersection modifications to improve operations and accessibility;
- A combination of cycle tracks and sidewalks or multi-use paths on both sides of Oxford Street West provide dedicated facilities for walking and cycling throughout the corridor.

The study was completed in accordance with 'Schedule C' requirements of the *Municipal Class Environmental Assessment (October 2000, as amended 2023)*, which is an approved process under the *Ontario Environmental Assessment Act*.

Environmental Study Report

An Environmental Study Report has been prepared to document the study process, recommendations, and potential impacts and mitigation measures. By way of this notice, the Environmental Study Report is being placed on the public record for a 30-day review period starting on **September 12, 2024 and ending on October 12, 2024**.
