THIS AGREEMENT made in duplicate the day of here.

BETWEEN:

MRS. MARJORIE BLACKBURN, LONDON, ONTARIO,
hereinafter called the "CLIENT" OF THE FIRST PART
-and-

LORCINI LTD., of the Town of Greensville, Ontario, hereinafter called the "ARTIST" OF THE SECOND PART

IN CONSIDERATION of the mutual covenants herein contained and the sum of ONE DOLLAR (\$1.00) now paid by each of the parties hereto to each other, receipt whereof is hereby by each of them acknowledged, the parties hereto do hereby covenant, undertake and agree as follows:

- 1. The Artist hereby covenants and agrees with the Client, for the consideration hereinafter expressed, to design, fabricate and execute an aluminum sculpture, approximately twenty feet high, based on the maquette which the Artist submitted to the Client and which the Client has examined and approved.
- 2. The sculpture will be completed on or about the 31st of August, 1986, subject to such reasonable extensions as the Artist might require for purposes of completing the work, or such reasonable extensions as the Client might require to complete the preparations of the site for the work.

The Artist will supply an appropriate anchor system in accordance with engineering standards appropriate to the location. He will deliver the sculpture to the site, and complete the installation on a concrete foundation which is to be supplied by the Client.

- 3. The Client agrees to pay to the Artist in consideration of the design, fabrication and execution of the sculpture and for its installation, the sum of SIXTY EIGHT THOUSAND DOLLARS (\$68,000) which shall be paid to the Artist as follows:
 - a) Upon execution of the within agreement by the parties hereto, the sum of TWENTY TWO THOUSAND DOLLARS (\$22,000).
 - b) Upon completion of the basic forms of the sculpture the sum of TWENTY TWO THOUSAND DOLLARS (\$22,000).
 - c) Upon full completion of the sculpture and its installation, the full balance of TWENTY FOUR THOUSAND DOLLARS (\$24,000).
- 4. The site for the installation of the sculpture is the CFPL Television Station, London, Ontario.
- 5. The Artist shall pay Federal Excise Tax and the Client shall pay the Provincial Sales Tax if applicable.

- The Artist will supply all materials necessary for the sculpture which shall be of good quality, appropriate to the sculpture and the design based on the aforesaid maquette. Deterioration due to the fault of the workmanship shall be the responsibility of the Artist for a period of one year from the date of completion of the installation. Any faults discovered within the said time shall be repaired at the expense of the Artist.
- 7. The Artist will insure the sculpture for its full value against risks of physical damage both while the work is in progress and after completion while it is in transit, such coverage to remain until the work is installed. In the event of damage to the risk, insurance proceeds for the damage will be paid to the parties hereto as their respective interests shall appear.
- 8. The Artist agrees that the sculpture will be one of a kind, and that any edition of maquettes will be produced only with the consent of the Client. Copyright in the sculpture shall be owned by the Artist.
