By-law No. W-8-14_____

A by-law to amend By-law W-8 entitled, "Regulation of Water Supply in the City of London."

The Municipal Council of The Corporation of the City of London enacts as follows:

1. Section 1 of Schedule A of By-law W-8 is amended by deleting the existing table and replacing it with a new table as follows:

2. Section 2.1 of Schedule A of By-law W-8 is amended by deleting the existing table and replacing it with a new table as follows:
