SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION


That on the recommendation of the Managing Director, Engineering and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on December 17, 2013 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. No Parking, No Stopping Zones

- a) Western University requires a shuttle service loading zone on the south side of Epworth Avenue west of Waterloo Street. Currently that shuttle service loading zone is posted as No Stopping, where No Parking would be more appropriate and allow for the active loading and unloading of passengers. A 'No Parking Anytime' zone is proposed to replace the 'No Stopping Anytime' zone. An amendment is required to Schedule 1 (No Stopping and Schedule 2 (No Parking)
- b) 695 Richmond Street requires a No Parking Zone to allow drop-offs from the residential high rise apartment building. It is proposed to adjust the existing No Parking Zone from 90 metres north of Mill Street to 75 metres north of Mill Street. An amendment is required to Schedule 2 (No Parking).
- c) Due to safety concerns with vehicles parking along the inside of the four curves on Jubilee Drive between Blackacres Drive and Hawthorne Road, 'No Parking Anytime' zones are proposed for the inside of the curves. An amendment is required to Schedule 2 (No Parking).
- d) Due to safety concerns with vehicles parking in the lane between both sides of Sherwood Forest Square, and along the inside of the west leg, 'No Parking Anytime' zones are proposed for the easement and the inside of the curves. An amendment is required to Schedule 2 (No Parking).
- e) Due to safety concerns with vehicles parking along the inside of the curve on Milestone Road north of Grenfell Drive, 'No Parking Anytime' zones are proposed for the inside of the curve. An amendment is required to Schedule 2 (No Parking).
- f) A mail-back survey was conducted on Dixie Street to determine if the homeowners supported the removal of overnight No Parking restriction during summer months. The results of the mail-back survey indicated that the majority of respondents supported the parking regulations change. An amendment is required to Schedule 2 (No Parking).
- g) Due to safety concerns with vehicles parked on the east side of Beaverbrook Avenue from Oxford Street West to Riverside Drive it is proposed to implement a 'No Parking Anytime' zone. An amendment is required to Schedule 2 (No Parking).



2. Regulatory Signs

- a) Due to operational safety concerns, it is proposed to replace existing Yield Sign with a Stop Sign at Carnforth Road at Grasmere Crescent. Amendments are required to Schedule 10 (Stop Sign Locations).
- b) Due to operational safety concerns, it is proposed to install Stop Signs on Driver Lane at Dundas Street and Auto Mall Avenue at Crumlin side Road. Amendments are required to Schedule 10 (Stop Sign Locations).

3. Through Highways

- a) Crestwood Drive from Commissioners Road to Longworth Road should be designated as a Through Highway to allow assignment to right-of-way control to intersecting streets. Amendments are required to Schedule 13 (Through Highways).
- b) Cedarhollow Boulevard from Fanshawe Park Road East to Kilarney Road should be designated as a Through Highway to allow assignment to right-of-way control to intersecting streets. Amendments are required to Schedule 13 (Through Highways).

4. School Bus Loading Zones

- a) Sir Georges Etienne Cartier Elementary School at 695 Chiddington Avenue requires an additional School Bus Loading zone on the north side of Chiddington Avenue at the east end of the school property limit. It is proposed to implement a 'School Bus Loading' zone within the existing 'No Parking 8:00 a.m. to 6:00 p.m. Monday to Friday September 1st to June 30th zone. An amendment is required to Schedule 16 (School Bus Loading Zones).
- b) St. Bernadette Elementary School at 155 Tweedsmuir Avenue requests a change to the existing 'School Bus Loading Zone' anytime to allow for parents to park within that zone after 4:00 p.m. to attend school events. It is proposed to change the existing 'Loading Zone' anytime to 'Loading Zone 8:00 a.m. to 4:00 p.m. Except Saturday'. An amendment is required to Schedule 1 (No Stopping), Schedule 5 (Loading Zones) and Schedule 16 (School Bus Loading Zones).

5. Revised Speed Limits

- a) An operational review of Wickerson Road between Byron Baseline Road and 50 metres south of Wickerson Gate recommended a speed reduction from the current 60 km/h to 50 km/h. An amendment is required to Schedule 17 (Higher Speed Limits).
- b) Due to increased development on Fanshawe Park Road West from Mallard Road to Derwent Road and Fanshawe Park Road East from 200 metres west of Highbury Avenue North to 1200 meters east of Highbury Avenue Road a speed reduction from the current 70 km/h to 60 km/h is recommended. An amendment is required to Schedule 17 (Higher Speed Limits).
- c) Due to increased development on Highbury Avenue North from Fanshawe Park Road East to 125 metres north of Blackwell Boulevard a speed reduction from the current 80 km/h to 70 km/h is recommended. An amendment is required to Schedule 17 (Higher Speed Limits).

6. <u>Designated Parking Spaces (Disabled persons)</u>

Staff received a request to install accessible parking space at 720 Dundas Street. It is proposed to replace two of the current 2 Hour Metered Parking spaces with two – 2 Hour Designated Parking Space on the north side of Dundas Street. Amendments are required to Schedule 27 (Designated Parking Spaces – Disabled Persons).

7. Piccadilly Street

Piccadilly Street from Talbot Street to St. George Street has been recently reconstructed resulting in changes to the 'No Parking' zones, 'Limit Parking' zones and 'One-Way Street' designations are required. Amendments are required to Schedule 2 (No Parking), Schedule 6 (Limited Parking) and Schedule 12 (One-way Streets)



APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. No Stopping
