YOUR COMMITTEE RECOMMENDS:

Parks and Recreation Area By-law PR-2 Amendments

- 1. (4) That the Civic Administration **BE ADVISED** that the Community Safety and Crime Prevention Advisory Committee (CSCP) supports the proposed amendments to the Parks and Recreation Area By-Law PR-2, a by-law to provide clarity on the exclusion of e-scooters from Multi-Use Pathways, Section 2.1 By-law Applicability Defined, as appended to the staff report dated November 11, 2013, and relating to "power-assisted bicycle", specific to:
- allowing e-bikes when powered by pedal, rather than motor, when being used on a bike path and/or designated bike lanes;
- requiring e-bike users to be at least 16 years of age; and,
- requiring e-bike users to wear helmets;

it being noted that the CSCP reviewed and received the above-noted Report from the Managing Director of Parks and Recreation, with respect to this matter, and received the <u>attached</u> fact sheets, from R. Black, London Police Service, on new and emerging vehicles, e-bikes, mopeds and motor scooters.
