SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

#### **RECOMMENDATION**

That on the recommendation of the Managing Director, Engineering and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on January 28, 2014 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

## BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

#### 1. No Parking and School Bus Loading Zone

The No Stopping zone and School Bus Loading zone on Topping Lane at Commissioners Road West are no longer required. An amendment is required to Schedule 1 (No Stopping) and Schedule 16 (School Bus Loading Zones).

#### 2. Residential Parking Pass Program (RPPP)

At the request of a resident, a mail-back survey was conducted on Waterloo Street north of Grosvenor Street to determine if the homeowners supported the implementation of the Residential Parking Pass Program (RPPP) from September 1<sup>st</sup> to April 30<sup>th</sup> to address the lack of parking for their visitors. Ten of the thirteen (77%) properties responded to the survey with seven (70%) properties supporting the RPPP. It should be noted that there is a fee associated with this RPPP which was detailed in the survey. Only one respondent objected to the fee; however, they also opposed the RPPP. An amendment is required to Schedule 6 (Limited Parking) and Schedule 6.1 (Limited Parking Residential-Parking Pass)

#### 3. Designated Parking Spaces (Disabled persons)

Staff received a request to install an accessible parking space at 140 Ann Street (Hutton House). It is proposed to change part of the current 2 Hour Limited Parking with a 2 Hour Designated Parking Space on the north side of Ann Street. During a review of this request a typographical error was found in Schedule 6 (Limited Parking) with respect to Ann Street which is being corrected at this time. An amendment is required to Schedule 6 (Limited Parking) and Schedule 27 (Designated Parking Spaces – Disabled Persons).



### APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

#### 1. No Stopping

Schedule "1" (No Stopping) of the said By-law PS-111 is hereby amended by **deleting** the following row:



Schedule "27" (Designated Parking Spaces – Disabled persons) of the said By-law PS-111 is hereby amended by **adding** the following row:
