YOUR COMMITTEE RECOMMENDS:

Meadowlilly Woods Designation 1. (iii) That the Civic Administration **BE REQUESTED** to initiate the assessment process to identify the Meadowlily Woods area as a cultural heritage landscape by assisting in the preparation of a cultural heritage evaluation study, including a conservation plan; it being noted that research assistance, with respect to the study, will be provided by the London Advisory Committee on Heritage (LACH) Stewardship Sub-Committee and the Friends of Meadowlily Wood; it being noted that the LACH heard from J. Lutman, on behalf of the Stewardship Sub-Committee, with respect to this matter.
