By-law No. PS-111-\_\_\_\_\_

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act, 2001*, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

**1. No Stopping**

Schedule "1" (No Stopping) of the said By-law PS-111 is hereby amended by **deleting** the following row:

Topping Lane	East	A point 50 m north of Commissioners Rd	A point 25 m north of said street	8:00 am to 6:00 pm Except Saturday
Topping Lane	West	Eaton Park Dr	Commissioners Rd	8:00 am to 6:00 pm Except Saturday

**2. Limited Parking**

Schedule "6." (Limited Parking) of the said By-law PS-111 is hereby amended by **deleting** the following row:

Ann Street	North	From Talbot Street	8:00 am to 6:00 pm	2 Hours
Waterloo S	East	From Cromwell Street to Grosvenor St	8:00 am to 6:00 pm	1 Hour Except Saturdays

Schedule "6." (Limited Parking) of the said By-law PS-111 is hereby amended by **adding** the following row:

Ann Street	North	From Talbot Street to St George Street	8:00 am to 6:00 pm	2 Hours
------------	-------	--	--------------------	---------

**3. Limited Parking Residential-Parking Pass**

Schedule "6.1" (Limited Parking Residential-Parking Pass) of the said By-law PS-111 is hereby amended by **adding** the following row:

Waterloo Street	East	From Cromwell Street to Grosvenor St	September 1 <sup>st</sup> to April 30 <sup>th</sup>	3
-----------------	------	--------------------------------------	---	---

**4. School Bus Loading Zones**

Schedule “16” (School Bus Loading Zones) of the said By-law PS-111 is hereby amended by **deleting** the following rows:

Topping Lane	East	A point 50 m north of Commissioners Rd	A point 25 m north of said street
--------------	------	--	-----------------------------------

**5. Designated Parking Spaces – Disabled persons**

Schedule “27” (Designated Parking Spaces – Disabled persons) of the said By-law PS-111 is hereby amended by **adding** the following row:

Ann Street	North	A point 90 m east of Talbot Street to a point 82 m east of the said street	8:00 am to 6:00 pm	2 Hours
------------	-------	--	--------------------	---------

6. This by-law comes into force and effect on the day it is passed.
