## I YOUR COMMITTEE REPORTS:

Natural Heritage Inventory and Evaluation Study for the Medway Valley Heritage Forest ESA, Phase One Conservation Master Plan 2. (4) That the Environmental and Ecological Planning Advisory Committee (EEPAC) heard a verbal presentation and received the Natural Heritage Inventory and Evaluation Study, from L. McDougall, Ecologist Planner, with respect to the Medway Valley Heritage Forest Environmentally Significant Area, Phase One Conservation Master Plan.
