SUBJECT:	APPOINTMENT OF CONSULTING ENGINEER FOR INSPECTION, CONTRACT ADMINISTRATION AND ENGINEERING SERVICES ASSOCIATED WITH THE CONSTRUCTION OF THE FOX HOLLOW SWM FACILITY NO. 1 – SOUTH CELL AND WOODLOT BERM (ES3020-FH1)

RECOMMENDATION

That, on the recommendation of the Director, Roads and Transportation, the following actions **BE TAKEN** with respect to appointment of a consultant for inspection, contract administration and engineering services associated with the construction of the Fox Hollow No. 1 SWM Facility – South Cell and Woodlot Berm:

- a) The engineering fees for Stantec Consulting Ltd. (171 Queens Avenue, Suite 600, London Ontario N6A 5J7) **BE ACCEPTED** to carry out the Inspection and General Construction Administration, including geotechnical, the monitoring of existing water wells, the post-construction monitoring in the total amount of \$245,481.50 including contingency, excluding HST; in accordance with Section 15.2(g) of the Procurement of Goods and Services Policy;
- b) the financing for the project **BE APPROVED** in accordance with the "Sources of Financing Report" attached hereto as Appendix "A";
- c) the consulting fees for the project identified in (a), above, **BE IN ACCORDANCE** with the estimate, on file, which are based upon the Fee Guideline for Professional Engineering Services, 2006, recommended by the Ontario Society of Professional Engineers;
- d) the Civic Administration **BE AUTHORIZED** to undertake all the administrative acts that are necessary in connection with this work;
- e) the approvals given herein **BE CONDITIONAL** upon the Corporation entering into a formal contract with the consultant for the work; and
- f) the Mayor and City Clerk **BE AUTHORIZED** to execute any contract or other documents, if required, to give effect to these recommendations.



BACKGROUND

Purpose

This report recommends the appointment of Stantec Consulting Ltd. to carry out inspection, contract administration, post construction monitoring and engineering services necessary to complete and construct the Fox Hollow Development Area SWM Facility No. 1 – South Cell / Woodlot Berm (location map is shown in Appendix B).


Context

The Fox Hollow Community Area is located within the "Medway Creek Subwatershed". This area of approximately 365 hectares is bounded by Sunningdale Road to the north, Wonderland Road to east, Fanshawe Park Road to the south and Hyde Park Road to the west. In addition, some external lands north of Sunningdale Road are a part of this catchment area.

In May 2010, the City engaged Stantec Consulting Ltd. for the functional and detailed design of storm/drainage, SWM and sanitary servicing works for the Fox Hollow development area in accordance with the addendum to the Fox Hollow Development Area Municipal Class Environmental Assessment (EA Addendum) for Storm/Drainage, SWM and Sanitary Servicing works finalized in July 2010. The scope of the engineering services for functional and detailed design did not include phasing of the SWM facilities.

In June 2012, staff recommended that current development plans, via the Growth Management Implementation Strategy (GMIS), could be implemented while deferring considerable capital spending and provide savings in debt related interest costs by phasing the large stormwater management facilities. It was proposed that the Fox Hollow No. 1 Facility be phased into two parts, North Cell and the South Cell / Woodlot Berm.

Construction of the Fox Hollow Development Area SWM Facility No. 1 – South Cell and Woodlot Berm will be the third municipally built component of the Fox Hollow Community Area SWM System and will allow for approximately 40 ha of land to the west and north to be developed. Storm flows from these areas will be captured by the SWM Facility and woodlot parcel to provide water quality, erosion and peak flow attenuation to protect the downstream Medway Creek system.



DISCUSSION

Stantec has completed the functional and detail design work for the Fox Hollow No. 2, Heard Drain, Fox Hollow No. 1 (south cell and woodlot berms) SWM facilities and has completed the functional design work for the Fox Hollow No. 1 (north cell) and Fox Hollow No. 3 SWM facilities. The fees associated with the engineering assignment for these works are approximately \$1,507,930.

Given their knowledge and experience on the project, Stantec Consulting Ltd. was requested to submit a proposal to carry out the inspection, contract administration, post construction monitoring and engineering services for the construction of the Fox Hollow No. 1 SWM facility (south cell and wood lot berms).

In accordance with Section 15.2(g) of the Procurement of Goods and Services Policy, Civic Administration is recommending that Stantec be authorized to carry out the remainder of engineering services to complete this project at an estimated cost of \$245,481. The continued use of Stantec on this project is of financial advantage to the City due to the fact that the firm has specific knowledge of the project and has undertaken work for which duplication would be required if another firm were to be selected. The approval of this work will bring the value of the overall consulting assignment to \$1,753,411.

The cost of the subject work for Phase 1 of Fox Hollow No. 1 (south cell and woodlot berms) prior to the tender opening was estimated in the amount of \$2,237,945 including contingency, excluding HST. The Contract for the construction of the Fox Hollow No. 1 SWM facility (south cell and wood lot berms) was tendered and awarded in accordance with the City's Procurement of Goods and Services Policy under the City's Administrative Approval process as the value of the tender was under three (3) million dollars. The total costs of the previously constructed SWM facilities and the subject works are approximately \$8.5 M.

CONCLUSIONS

Stantec Consulting Ltd. has demonstrated an understanding of the City requirements for this project and has extensive knowledge of the project. The continued involvement of Stantec Consulting Ltd. is in the best financial and technical interests of the City. It is recommended that the engineering fees of the City's consultant (Stantec Consulting Ltd.) be increased by \$245,481.50 including contingency, excluding H.S.T. to carry out the Inspection and General Construction Administration, including geotechnical, the monitoring of existing water wells, the post-construction monitoring and engineering services for the project.
