(7) That the Mayor BE REQUESTED to submit a letter in support of the Federation of Canadian Municipalities' "Fixing the Housing Crunch" campaign to all federal and provincial parties with respect to making affordable housing a priority, and an emphasis on non-profit, private and inter-governmental partnerships for the provision of affordable housing; it being noted that the London Housing Advisory Committee (LHAC) received communications from L. Stevens, Director, Municipal Housing, with respect to the City of London Housing Summit held February 5, 2014.

Imminent Loss of

2. (Added) That the Civic Administrator BE REQUESTED to:
- a) include all available information with respect to federal housing cooperatives in the "End of Housing Operating Agreements" report currently under preparation;
 - b) explore the role of the City with respect to the immediate need of those individuals facing the imminent loss of housing rent subsidy; and,
 - c) explore means to support those who may be in need while awaiting action from the federal government;

it being noted that the LHAC recognizes that preventing homelessness is preferred from a social, financial and societal aspect and is part of the current housing plan; it being further noted that the City does not have administrative jurisdiction over federal housing cooperatives.
