### I YOUR COMMITTEE RECOMMENDS:

By-laws, Policy and Training Sub-Committee

- 1. (b,4) That the following actions be taken with respect to the By-laws, Policy and Training Sub-committee report from its meeting held on March 11, 2014:
- a) Civic Administration BE REQUESTED to attend a meeting of the ACCAC to discuss:
  - i) the potential re-naming of Sanitorium Road; and,
  - ii) a review, and potential amendment to Section 4.8 Group Homes of the Z-1 Zoning By-law with respect to potential changes to minimum separation distance requirements; and,
- the ACCAC Chair BE DIRECTED to discuss Spectrum program costs for programs specifically for disabled persons.

Education and Awareness Sub-Committee
