SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION

That on the recommendation of the Managing Director, Engineering and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on May 6, 2014 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. Byron Northview Public School

The No Stopping, No Parking and School Bus Loading zones on Stephen Street south of Commissioners Road West require changes due to the increase in the number of school buses attending Byron Northview School. Placing time limits on the No Stopping and No Parking zones is recommended to address traffic flow at the school.

An amendment is required to Schedule 1 (No Stopping), Schedule 2 (No Parking) and Schedule 16 (School Bus Loading Zones).

2. No Stopping

Due to safety concerns, it is recommended to implement a No Stopping 8:00 am to 9:00 am and 3:00 pm to 4:00 pm Except Saturday 1st to June 30th zone on the north and south side of Carrick Lane from Sunnyside Drive to about 43 m east of Sunnyside Drive

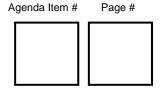
Due to safety concerns with pedestrians crossing to access the Carling Recreation Centre, it is recommended that the No Stopping zone on Grosvenor Street between Elliott Street and Taylor Street be relocated from the south side to the north side. This will allow for drop-offs and pick-ups on Grosvenor Street on the same side as the Community Centre. A No Parking zone at the driveway to the Carling Recreation Centre will be created to ensure access to and from the parking lot is not impacted. A Loading zone at the north entrance to the Carling Recreation Centre will be created to ensure there is available space to actively load and unload of people and goods.

At the request of local residents on Regis Avenue, a survey was conducted with the majority of the respondents in favour of implementing a No Stopping 8:00 am to 4:00 pm Except Saturday zone on the west side of Regis avenue from Wayne Road to the northern limit.

An amendment is required to Schedule 1 (No Stopping), Schedule 2 (No Parking) and Schedule 5 (Loading Zone)

3. No Parking

Due to safety concerns with vehicles parking on the inside of the curve, it is recommended to remove the No Parking Anytime zone on the east side of Aldersbrook Road from Sarnia Road to Sherbourne Crescent (outside of the curve) and implement a No Parking Anytime Zone on the west side of Aldersbrook Road from Sarnia Road to



Sherbourne Crescent (inside of the curve).

Due to safety concerns it is recommended to implement a No Parking Anytime zone on north side of Cedarpark Crescent (south leg).

Due to safety concerns, it is recommended to implement a No Parking Anytime zone on the inside of the curve at #878 Cresthaven Crescent.

At the request of local residents on Great Oak Court, a survey was conducted with the majority of respondents in favour of implementing a No Parking 8:00 am to 4:00 pm, Monday to Friday September 1st to June 30th zone for all of Great Oak Court.

Due to safety concerns, it is recommended to implement a No Parking Anytime zone on the inside of the curve at #105 Lonsdale Drive.

At the request of local residents on Queens Place, a survey was conducted with the majority of respondents in favour of extending the existing No Parking Anytime zone on the east side of Queens Place from Queens Avenue to the north limit of Queens Place.

At the request of local residents on Winblest Avenue, a survey was conducted with the majority of respondents in favour of decreasing the existing No Parking Anytime zone from 70 m west of Nadine Avenue to 20 m west of Nadine Avenue.

An amendment is required to Schedule 2 (No Parking) for the above changes.

3. Limited Parking

Recent discussions with a local property/business owner determined that Limited Parking zone on the south side of Piccadilly Street would be more beneficial than on the north side.

At the request of local residents on Wellington Street a survey was conducted with the majority of respondents in favour of removing a No Parking Anytime zone and extending the existing 1 hour Limited Parking 8:00 am to 9:00 pm, Monday to Saturday zone on the east side of Wellington Street north of St James Street.

An amendment is required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking).

4. Prohibited Turns

Due to safety concerns it is recommended to implement a No U-Turn for westbound traffic on Sarnia Road at Chapman Court and on Sarnia Road at Aldersbrook Road.

Due to safety concerns it is recommended to implement a No U-Turn at the intersection of Wonderland Road and Aldersbrook Road for northbound and southbound traffic.

An amendment is required to Schedule 8 (Prohibited Turns).

5. Regulatory Signs

Due to operational safety concerns, it is proposed to replace existing Yield Sign with a Stop Sign on Virginia Crescent at Virginia Road for both east and west intersections.

Amendments are required to Schedule 10 (Stop Sign Locations) and Schedule 11 (Yield Signs).



APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:


