Current Pet Limits for Cats and Dogs

Household	PH-4 Dog (3 dogs per household)	PH-3 Cat (2 cats per adult per household)	Total Allowed

Pet Limits for Cats and Dogs

Pet limits need to be connected to responsible pet ownership.

Proposed is maximum of 3 cats and dogs in any combination in a dwelling unit.

Proposed is a maximum of 8 cats and dogs in any combination where there is not more than 3 dogs and all pets are spay/neutered and are up-to-date with vaccinations.

Proposed new /citizen resident of London clause. If a new resident can provide proof of a current valid licenses for a higher number of spay/neutered, vaccinated pets, they would be deemed compliant.





Fostering Pets Fostering is an important life saving component of animal services

- It is proposed that a foster home can have a total combination of 10 cats or dogs where the number of dogs does not exceed 4.
- City of London approved rescue organizations will be given special tags for foster dogs residing within the boundaries of London. The tags would be issued annually.
- Each Foster Home would receive "Foster Card" which could be presented to a Animal Control Officer if the limit is in question. The card would identify the associated rescue organization.
- Rescue organizations will actively promote responsible pet ownership and the benefits that licensing/registration provide.

- Many of the challenges we face come from unaltered cats and dogs.
- Proposed fees are connected to responsible pet ownership.
- Proposed increase to unaltered cats and dogs only.
- Proposed senior citizens discount of \$5.00 in all categories.
- Proposed reduction for cats and dogs S/N and micro-chipped.
- Pet Owner Rewards Card program has been implemented to encourage voluntary licensing



Micro-chipping

- Micro-chipping combined with licensing has proven to be the best method to reunite lost pets with their owner.
- The micro-chip itself is the size of a grain of rice and is surgically implanted via a non evasive procedure that takes very little time.
- Currently London Animal Care Centre Microchips pets in adoption program.
- Need to encourage London pet owners to microchip their pets
