Bill No. 273 2014 By-law No. A.-____

A By-law to authorize the Managing Director, Housing, Social Services and Dearness Home or designate to execute documents re: the Dearness Home with the Local Health Integration Networks (LHIN) or with Her Majesty The Queen in Right of Ontario (Minister of Health and Long-Term Care) and to repeal by-laws A.- 6741-310 and A.-6251-286 and to delete section Section 3 of By-law A.-6938-114 and section 2 of By-law A.-6555-212.

WHEREAS subsection 5(3) of the *Municipal Act, 2001* S.O. 2001, c.25, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS section 23.1 of the *Municipal Act, 2001* authorizes a municipality to delegate its powers and duties under this or any other Act to a person or body subject to the restrictions set out in Part II of the *Municipal Act, 2001*;

AND WHEREAS The Corporation of the City of London (the "City") has established and maintains a municipal long-term care home under the *Long-Term Care Homes Act*, 2007, S.O. 2007, c.8:

AND WHEREAS the City operates an Adult Day Program under the *Home Care* and *Community Services Act, 1994*, S.O. 1994, c. 26;

AND WHEREAS the City has entered into Service Accountability Agreements with the South West Local Health Integration Network (LHIN) with respect to both the long-term care home and the adult day program;

AND WHEREAS the "Delegation of Powers and Duties Policy", Schedule "G" to By-law A.-6151-17 sets out the guidelines that apply when London City Council delegates its powers and duties;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. Subject to paragraph 2 below, the City's Managing Director, Housing, Social Services and Dearness Home, or his or her written designate, with respect to the City's long-term care home and the City's Adult Day Program, is hereby delegated the authority to:
 - (a) approve and execute documents required by LHIN under agreements with LHIN (including reports, acknowledgements, amendments to the Service Accountability Agreement, and Project Funding Agreements as defined in a Service Accountability Agreement, but excluding Service Accountability Agreements); and
 - (b) act as the City Representative for purposes of any Project Funding Agreement as defined in a Service Accountability Agreement, and for such purposes is delegated the authority to bind the City; and
 - (c) approve and execute documents required under agreements with Her Majesty The Queen in Right of Ontario as represented by the Minister of Health and Long-Term Care (including reports, acknowledgements, amendments to the agreement, but excluding agreements).
- 2. The authority delegated in paragraph 1 is subject to the following conditions: that the document to be executed does not require additional funding beyond that provided for in the City's current budget; that the document does not provide for an indemnity to be given by the City; to the extent that any agreement provides for confidentiality the agreement must conform

to applicable Ontario Legislation; and that the delegate provides an annual report to Council regarding any such documents executed or declarations made.

- 3. The power or duty delegated may be exercised by both the delegate and the municipality.
- 4. By-law A.-6741-310 and By-law A.-6251-286 are hereby repealed.
- 5. Section 3 of By-law A.-6938-114 and section 2 of By-law A.-6555-212 are hereby deleted.
- 6. This by-law shall come into force and effect on the day it is passed.
