By-law No. PH-5-14_____

A By-law to amend By-law PH-5 entitled "A by-law to provide for the Appointment of a Poundkeeper and to regulate the Public Pound"

WHEREAS subsection 5(3) of the *Municipal Act, 2001* S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS subsection 10(2) of the *Municipal Act, 2001* provides that a municipality may pass by-laws respecting "economic, social and environmental well-being of the municipality", "health, safety and well-being of persons", "protection of persons and property", and "animals";

AND WHEREAS the provisions of the *Pounds Act* and the *Animals for Research Act* apply with respect to a pound and a poundkeeper;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The By-law Index of By-law PH-5 is amended as follows:
 - (a) Section 1.1 is amended by deleting the phrase "Animal Care and Control Centre (London)" and replacing it with the phrase "London Animal Care Centre";
 - (b) Section 3.1 is amended by deleting the heading in its entirety and replacing it with the phrase "Electronic Database – contents"; and
 - (c) Section 3.2 is amended by deleting the heading in its entirety and replacing it with the phrase "Database – provide access".
2. Section 1.1 and section 2.1 of By-law PH-5 are amended by deleting the phrase "Animal Care and Control Centre (London)" wherever it appears and replacing it with the phrase "London Animal Care Centre".
3. Section 3.1 of By-law PH-5 is amended by deleting the heading and replacing it with the following heading "Electronic Database - contents".
4. Section 3.1 of By-law PH-5 is amended by deleting the phrase "City Treasurer shall furnish the".
5. Section 3.1 of By-law PH-5 is amended by deleting the phrase "with a book" and replacing it with the phrase "shall maintain an electronic database system".

6. Section 3.2 of By-law PH-5 is deleted in its entirety and replaced with the following new section 3.2 as follows:

3.2 Database – provide access

The Poundkeeper shall at all times produce and provide access to the electronic database system when required to do so by the Managing Director of Development and Compliance Services & Chief Building Official.

7. This by-law shall come into force and effect on the day it is passed.
