I YOUR COMMITTEE RECOMMENDS:

London Block Parent® – Wellington Road Signage

1. (4) That, notwithstanding part 11(e)(iii) of clause 5(16) of the Policy Manual, which indicates that financial grants/contributions or awards to third party individuals, organizations or groups shall be directed to the appropriate Civic Department to be addressed through the approval and reporting processes already established by the Municipal Council for those situations, the amount of \$330.00 for the replacement of the London Block Parent® sign on Wellington Road **BE APPROVED** from the Community Safety and Crime Prevention Advisory Committee's (CSCP) 2014 Budget; it being noted that the CSCP reviewed and received a communication from M. O'Halloran, Executive Director, London Block Parent® Program, with respect to this matter.

2.
