Animal Services – Pet Limit Bylaw

- 1. (5) That the Civic Administration **BE REQUESTED** to consider, in addition to what has already being presented in relation to the By-law No. PH-3, a two-year pilot project consisting of the following:
- a) a complete exemption from the pet limit restrictions be available only to those foster homes that are situated in a "single detached dwelling", as defined by the City of London Zoning By-law No. 2.-1; it being noted that foster homes that do share walls, such as town-houses and apartments, would adhere to the established foster pet limits; and,
- b) only foster homes working under the direction of recognized rescue groups that follow a set standard of animal adoption and animal keeping practices and other criteria, that are currently being developed by Staff through discussions with the Animal Welfare Advisory Committee (AWAC) and rescue groups, be granted a complete exemption as noted in a), above;

it being noted that the AWAC reviewed and received a communication dated June 5, 2014, from V. Van Linden with respect to this matter.
