MATTERS CONSENTED TO BY THE COMMITTEE:

Property Standards Issues 1. (7) That, on the recommendation of the Commissioner of Planning and Development, clause 2 of the 2nd Report of the London Housing Advisory Committee (LHAC) from its meeting held on April 18, 2000, BE **DELETED** and **NOT BE APPROVED**; it being noted that clause 2 of the 2nd Report of the London Housing Advisory Committee (LHAC) read as follows:

"That By-law CP-16 - Standards for the Maintenance and Occupancy of Property BE AMENDED to add the following subsection to section 3.1 of Part 3 - Environment:

'3.1.7 Furniture - Exterior Use
All furniture used for exterior use shall be of a material that readily repels water. Furniture that becomes dilapidated shall be disposed of." (5.2.2.)

MAPAG Update, Summer 2000

- 2. (2) That, on the recommendation of the Commissioner of Community Services, the following actions be taken with respect to the Mayor's Anti-Poverty Action Group (MAPAG) Fund:
- (a) funding in the amount of \$38,018 BE ALLOCATED by the City of London to Life*Spin for the Green Market Basket program for a one year period; it being noted that the provision of this funding will require the submission of a six month progress report and a final report after the full year, stating the outcomes and reporting the financial status of the program;
- (b) the Community Services Department continue to work with community organizations to refine outstanding requests for funding and report back to the Community and Protective Services Committee regarding the allocation of the remaining funds in the amount of \$54,645.71; and
- (c) at the request of the United Way of London & Middlesex, consideration of the recommendation to approve funding in the amount of \$144,562.29 to the United Way of London and Middlesex for the THAW 2001 Program BE POSTPONED until the CPSC meeting to be held on September 25, 2000, to permit further exploration of the provincial "Share the Warmth Program" and its potential inclusion of communities in southwestern Ontario and further that the recommended funding in the amount of \$144,562.29 remain uncommitted pending the September 25, 2000 review of this matter. - 6. (20) That, on the recommendation of the London Police Services Board:
- (a) the Mayor and Clerk **BE AUTHORIZED** to execute the <u>attached</u>
 Protocol between The London Police Services Board and The

- (b) the <u>attached</u> London Police Service Business Plan 2001-2003 BE RECEIVED. (62.1.1.)

Review of Community Action and Outreach Plan

- 7. (23) That, on the recommendation of the Hate Crime and Bias Activity Steering Committee (HCBASC), the Civic Administration, in consultation with the HCBASC and in partnership with the London Police Services Board, BE REQUESTED to investigate and report back to the Community and Protective Services Committee (CPSC) with respect to initiatives that could be undertaken immediately in the community in order to forestall hate crime and bias activity, including those strategies contained in the Hate Crime and Bias Activity: A Community Action Plan report (as revised March, 2000), noting that such initiatives will focus on the following areas of concern:
- · Public education and outreach
- Media relations
- Inventory and publication of community support services
- · Public bulletins
- Community roundtable
- Establishment of an office to receive and act upon complaints of hate crime and bias activity;

it also being noted that the HCBASC has established an ad hoc working group (L. Norman, S. Honyust, D. Lee, J. Mitchell, E. Pensa, T. Simpson, M. Tronsco, and H. Usher) to assist the Civic Administration with the development of strategies related to the above.

Adoption of the Race Relations Policy & Diversity Policy

- 8. (24) That, on the recommendation of the London Race Relations Advisory Committee (LRRAC), the following actions be taken with respect to the adoption/endorsement of the principles of the London Race Relations Policy and the Diversity Policy for the City of London by local Boards and Commissions:
- (a) the London Ecohomic Development Corporation, London Hydro, London Police Services Board and the Upper Thames River Conservation Authority BE REQUESTED to confirm their adoption of the principles of the London Race Relations Policy; and
- (b) all Boards and Commissions which receive funding from The Corporation of the City of London BE REQUESTED to endorse the principles of the Diversity Policy for the City of London;
- (c) the Boards and Commissions identified in parts (a) and (b) above BE REQUESTED to advise the LRRAC upon the adoption and/or endorsement of the principles of these policies; and
- (d) the Civic Administration BE REQUESTED to review organizational implementation models addressing race relations policies and report back to the CPSC with respect to preferred options that would achieve positive results in the community.

Business Plan Protocol

- It is the policy of the London Police Services Board that, the Board, in consultation with the Chief of Police, shall enter into a protocol with Municipal Council, for the communication, to Municipal Council, of the Business Plan and Annual Report. The protocol shall indicate that:
 - (a) the Business Plan is to be written every three years and provided to Municipal Council by July 1st of the year in which it is prepared;
 - (b) the Board shall make the Business Plan available to the public by August 1st of the year in which it is prepared;
 - (c) the Board shall invite members of the Municipal Council to participate in the consultation process for the development of the Business Plan;
 - (d) the London Police Service Annual Report shall be provided to Municipal Council by July 1st.

The Chief of Police shall prepare a report to the Board, on an annual basis, as to the compliance of the London Police Service with the objectives and performance indicators contained within the Business Plan. This report shall be delivered to the Board by July 1st each year.

PROTOCOL BETWEEN THE LONDON POLICE SERVICES BOARD AND THE MUNICIPAL COUNCIL OF THE CITY OF LONDON

The London Police Services Board (the Board) and the Municipal Council of the City of London (Municipal Council), agree upon the following protocol for the communication of the London Police Services Business Plan and Annual Report.

- (a) the Business Plan is to be written every three years and provided to Municipal Council by July 1st of the year in which it is prepared;
- (b) the Board shall make the Business Plan available to the public by August 1st of the year in which it is prepared;
- (c) the Board shall invite members of the Municipal Council to participate in the consultation process for the development of the Business Plan;
- (d) the London Police Service Annual Report shall be provided to Municipal Council by July 1st.
