I YOUR COMMITTEE RECOMMENDS:

Demolition Permit Application – 915 Queens Avenue 1. (5) That the Civic Administration **BE ADVISED** that the London Advisory Committee on Heritage does not object to the proposed demolition of the building located at 915 Queens Avenue.

Demolition Permit Application – 2526 Oxford Street West

- 2. (6) That the following actions be taken with respect to the proposed demolition of the Priority 1 building located at 2526 Oxford Street West:
- a) the Civic Administration BE ADVISED that the London Advisory Committee on Heritage (LACH) expressed regret for the possible loss of a heritage resource, but does not object to the demolition of the building located at 2526 Oxford Street West; and,
