London Transit Commission 1. Youth Gangs in London 2. That the Community Safety and Crime Prevention Advisory Committee (CSCP) heard a verbal delegation from Detective Constable B. Armstrong, Guns and Gang Unit, London Police Service, with respect to youth gangs in London.

Sample of How Block Parents Have Helped in London Recently



June 2009 – South – A father was physically hitting his 12 year old daughter. She ran to a neighbouring Block Parent® home for help. Father followed her there and was banging on the door. The police were called.

October 2010 – West - Block Parent® allowed a young child to use her washroom on Halloween night

December 2010 – Northwest – A senior's car broke down on the road and they went to a Block Parent® to call a garage for them.

March 2011 – South - 10 year old boy thought he was being followed by a car. BP called his parents and the mother came to pick him up.

April 2011 – Adult woman when to a Block Parents door because her hands were freezing. Block Parent® let her in to warm up and helped her with her groceries.

May 2011 – West – Block Parent intervened in a bullying incident outside of her home between two 9 or 10 year old boys. Block Parent® offered to help resolve the matter. The boys eventually calmed down and disbanded.

June 2011 – North West - A young boy had his pant leg stuck in his bicycle. BP helped them get the pant freed and the boys went on their way.

June 2011 – East - 8 year old child new to neighbourhood was lost and in distress. Parent had missed the child at school and the Block Parent® called home and mother came to pick up the child. Father dropped by the next morning to introduce himself and thank our Block Parents for helping their daughter.

June 2011 – West – 10 year old child fell off bicycle. Block Parent® provided band aid and an older child from school waited to walk him the rest of the way to school. BP called the school to let them know the children were going to be late for school and why.

August 2011 – South - An adult woman got a flat tire and went to a nearby Block Parent® to use the phone to call for help.

November 2011 – Central – Block Parent® helped two boys who were fighting outside of his home to stop fighting and the boys headed off to school. The incident was reported to the school.
