- The Safety Village was available for bookings on 180 days. This number accounts for holidays and PD days.

Current program offerings

SK: Dec, Feb, Mar

Grade 1: Sept, Oct, Nov, Dec, April

Grade 2: Dec, Jan, Feb Grade 4: May, June

SK is a 90 minute program

Grade 1, 2 and 4 are 120 minute programs

Some implications of cutting program to 3 days a week

Number of available days (this accounts for holidays and PD days) based of the 2013-14 school year

- Total number of program days available under 5 days of programming = 180
- Total number of program days available under 3 days of programming = 108
- Resulting in a loss of 72 days of available service

Average number of students experiencing the program



- Total number students of 11,283 divided by the total number of available days 180 = 62.7
 - o the average number of students served per day of available programming under 5 days of operations = 62.7
- Assuming that class sizes remain the same, reducing the program to a 3 day schedule would have the following impact
 - o 108 days available by 62.7 students = 6,772

4,511 students would not be able to participate in the program due to the reduction of available days.
