SUBJECT:	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

# RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on December 18, 2014 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

# BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

#### 1. No Parking

Due to safety concerns, it is recommended that 'No Parking Anytime' zones be implemented at the following locations:

- The inside of the curve at 102 and 106 Ashley Crescent;
- The inside of the curve at 1405 Corley Drive;
- The inside of the curve at 2129 Pennyroyal Street;
- The south side of Shore Road from Riverbend Road to 207 meters west of Riverbend Road;
- The east side of Cuddy Boulevard by an additional 50 meters southerly (opposite 5 Cuddy Boulevard's truck entrance); and
- Both sides of Kains Road to the northerly limit of the Oxford Street West left-turn lane.


Amendments are required to Schedule 2 (No Parking) for the above changes.

# 2. Taxi Stands and Loading Zones

A fire hydrant is currently located within the taxi stand and loading zone on the north side of Dundas Street east of Clarence Street. It is necessary to shorten the taxi stand and loading zone on the north side of Dundas Street east of Clarence Street by 4 meters so that the fire hydrant remains clear.

The taxi stand on the east side of Wellington Street north of Grosvenor Street is no longer needed due to changes in the configuration of St. Joseph's Hospital. A single 'Police Only' stall will be maintained.

An amendment is required to Schedule 4 (Taxi Stands) and Schedule 5 (Loading Zones) for the above changes.



### 3. <u>Limited Parking</u>

At the request of local property owners on Stirrup Court, a survey was conducted with the majority of respondents in favour of changing the existing unlimited parking on the west side to '2 hour Limited Parking 8:00 am - 6:00 pm, Monday to Friday', in order to address property owners needs for on-street parking. A review of Scheduled 2 (No Parking) identified that the existing signed 'No Parking Anytime' zone on the east side of Stirrup Court was missing from the by-law.

At the request of local property owners on Wellington Street between St. James Street and Grosvenor Street, a survey was conducted with the majority of respondents in favour of changing the existing '1 hour Limited Parking, 8:00 am to 9:00 pm, Monday to Saturday' on the east side to '2 hour Limited Parking 8:00 am to 6:00 pm Monday to Friday', in order to address changes in the on-street parking needs.

Amendments are required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking) for the above changes.

# 4. Stop and Yield Signs

Due to safety concerns, it is recommended to replace the existing Yield Sign on Chantry Place at Plane Tree Drive with a Stop Sign.

The development of Sunningdale Meadows subdivision has reached significant completion and the developer has requested that regulatory signs for traffic control be installed.

It is recommended to implement Stop Sign control at the following locations:

- Creekridge Bend at Callingham Drive;
- Waterside Terrace at Callingham Drive; and
- Waterside Terrace at Creekridge Bend.

It is recommended to implement Yield Sign control at the following locations:

- Waterside Close at Waterside Terrace; and
- Waterside Court at Waterside Terrace.

Amendments are required to Schedule 10 (Stop Sign Locations) and Schedule 11 (Yield Sign Locations).

#### 5. Speed Limits

A review of the posted speed limit on Kains Road and Shore Road identified a need to reduce the speed from 60 km/h to 50 km/h due to the substantial completion of the residential subdivision and the opening of new school.

An amendment is required to Schedule 17 (Higher Speed Limits.)

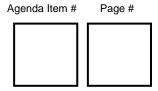

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. Of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;






