Work experience: **I have been a professor at King's since 2003. At King's I teach management, specifically, the subjects corporate governance and international business. I am currently the coordinator of the BMOS program at King's which involves academic oversight of roughly 20 faculty and 400 students in terms of planning, course content, academic integrity and staff hiring.**

Education: **I hold a B.A. (hons. Sociology) from King's and an MBA and PhD from the Ivey School of Business.**
