Subject: London Convention Centre Corporation Board of Directors Appointment

Recommendation:

The LCC Board of Directors recommends that John Irwin, CFO, CIO and Vice President of The Ivey Group of Companies be appointed to the London Convention Centre Board of Directors for a three year term starting January 2012.

Background:

Under Section 4.1 of City of London By-law NO. A-5357-298 the LCC Board currently consists of the Mayor as a member ex officio and ten members appointed by Council with the following board category recommendations:

- Two members of Council
- One member whom may but need not be engaged full-time in the hospitality sector
- One member whom may but need not be engaged full-time in the travel and transportation sector
- One member whom may but need not be engaged full-time in the health care sector
- One whom may but need not be engaged full-time in the business sector
- One whom may but need not be engaged full-time in the marketing or public relations sector
- One whom may but need not be a member of the group known as "Emerging Leaders"
- Two additional members

The LCC Board strategically seeks new Board members who are influential in an industry field and who are able to assist the LCC with introductions to potential new convention ambassadors and potential new convention opportunities for the City. In October 2011, Kerry Gerber, current Vice Chair of the LCC Board of Directors advised that he would not be able to complete his current term. Kerry is a Partner with Pricewaterhouse and brought a strong financial management approach to the LCC Board. John Irwin, CFO, CIO and Vice President of The Ivey Group of Companies, brings not only a wealth of financial knowledge to the LCC Board but also industry specific facility knowledge as he currently oversees several Ivey conference centres. Professional Accomplishments

- Initiated Ivey's New Building Task Force and currently serving as the New Ivey Building Project Manager—estimated value of the completed building is \$110 million.
- Serving on the India Strategy Task Force with the Ivey Executive Committee exploring opportunities for degree and non-degree business opportunities in India
- Initiated and currently serving on Ivey's Asia Strategy Task Force—Phase 2 where the goal is to determine and implement the school's next expansion into mainland China.
- Located, secured financing, and supervised the design and construction of Ivey's ING Leadership Centre within the Exchange Tower in downtown Toronto \$3 million capital project.

This agreement was unique to all North American publically funded Business Schools.
