Dog Parks Subcommittee

1. Incident on Halloween night. Most information gathered has not been completely confirmed however a phone call was made to the LDOA at approximately 3pm on Halloween night. A woman was walking her Beagle when she was approached on Blanchard St. by two children ages approximately 9 and 11 and asked if they could walk her dog. She said no but then they proceeded to tell her they had had a dog/dogs (unclear if there was one or two), however the previous Saturday Oct. 29<sup>th</sup>, their parents bound the dogs mouth and head with tape and put the dogs in a box and hid the box in the evening at one of the dog parks. The children were dressed poorly for that day in shorts and t-shirts although it was cool outside

I proceeded to get in touch with people and we started looking for a box in the dog parks. Later a call was placed to LACC and it was confirmed a box was found in a park near Blanchard St. by LHS. A call was placed to LHS who indicated that a box was found but would not give out any other details.

2. Email regarding a dog napper in Stoney Creek Park. (1 just received it this afternoon)

On Thursday, November 17 in the early afternoon I was at the Adelaide/Windermere dog park with my two dogs. One is a one year old Labradoodle named Cocoa and the other is a 3 year old Shephard/Retriever mix named Nicole. I was down on the path on the far side from Adelaide just standing there with Cocoa while Nicole sniffed around in the tall grass. She was a fair distance from me but I could see her. A man appeared in the grassy area and stood about four or five feet from Nicole. He looked around a few times, saw me with the doodle, and I presume he decided that Nicole was probably not my dog. At this point Nicole was just standing there looking at him. The man reached to his clothes and produced a leash. He approached Nicole, bending down with his left arm outstretched to grab her collar and the right arm coming towards her with the leash in hand. Before I could even yell Nicole lunged at him with a very ferocious growl, hair raised, and then stood in what looked like an attack stanch. She continued to growl. The man took off. She stayed where she was standing until I called her. Let me briefly mention that Nicole is a totally complacent, gentle and non-aggressive dog. She is friendly with all dogs, people, kids and anyone she meets. She clearly felt a real threat and held her ground. I am happy about that for her. I am upset, disturbed and worried for other people and their pets to think that someone is prowling the dog park to steal an animal.

The man was Caucasian, probably about 5'9". Black hair. Around late thirties, heavier build about 290lbs. Dark jacket, blue jeans.

It started and ended quickly so I only had a minute or two to observe his appearance. I don't know where he went as I did not see him in the park after the incident.

I have started to warn people as I speak with them in the park.

- 3. **Re: Noise at Greenway** I am continuing to monitor Greenway Park. I have been there at least 3 times a week and have heard very little noise and when a dog does bark it is usually very quick and doesn't last long at all. I have been there as early as 8 am and as late as 7pm. I also have been to the other dog parks and I must say that Greenway is the quietest of all three during the times I am there.
- 4. Saftey issues in the Parks are now being addressed and fixed in a more timely manner since I discussed this issue with AWAC. I am pleased with the much improved correspondence.
