Attached are the Building Division's monthly report for November 2011 and copies of the Summary of the Inspectors' Workload reports.

## Permit Issuance

By the end of November, 3,716 permits had been issued with a construction value of approximately 912.1 million dollars, representing 1,186 new dwelling units. Compared to last year, this represents a $14.5 \%$ decrease in the number of permits, a $41.2 \%$ increase in the construction value and a $29.7 \%$ decrease in the number of dwelling units.

To the end of November, the number of single and semi detached dwellings issued were 674, which was a $30.2 \%$ decrease over last year.

At the end of November, there were 326 applications in process, representing approximately 167 million dollars in construction value and an additional 606 dwelling units, compared with 297 applications having a construction value of 205 million dollars and an additional 435 dwelling units for the same period last year.

The rate of incoming applications for the month of November averaged out to 13.9 applications a day for a total of 306 in 22 working days. There were 52 permit applications to build 52 new single detached dwellings, and 25 townhouse applications to build 89 units, 11 of which were cluster single dwelling units.

There were 347 permits issued in November totalling $\$ 75,430,100$ including 119 new dwelling units.
Analysis of the issue dates show that for the month of November all types of permits, $25 \%$ were issued within 1 week, $46 \%$ were issued within 2 weeks and $72 \%$ were issued within 3 weeks. The report indicates that for single and semi detached dwellings, $21 \%$ were issued within 1 week, $40 \%$ were issued within 2 weeks, $75 \%$ were issued within 12 days, and $85 \%$ were issued within 3 weeks and 4 weeks.

Due to the Amanda reporting on scheduling inspections which inflates the numbers, only one inspection call per permit is counted, and only one inspection completed per permit is recorded

Building Inspectors received 1,359 inspection calls and conducted 1,742 building permit related inspections with an additional 57 inspections completed relating to complaints, licenses, orders and miscellaneous inspections. This is a total of 1,799 inspections or an average of 180 inspections made per inspector this month based on 10 inspectors, which averages out to 9.1 inspections per day per inspector. (Note: 220 person working days 22 vac/sick day/training $=198$. There are a total of 9,624 active building permits or an average of 962 permits per inspector.

Plumbing Inspectors received 709 inspection calls and conducted a total of 856 permit related inspections, there were 17 inspections performed that related to the Backflow Prevention Program. Inspections relating to complaints, orders and miscellaneous calls totalled a further 3 inspection. During the month a total of 876 inspections were conducted with an average of 175 per inspector, which averages out to 9.1 inspections per day per inspector*. (Note: 110 person working days -14 vac/sick day/training $=96$ ). Active building permits involving plumbing totalled 3,479 or 696 on average per inspector.
