SUBJECT:	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

#### **RECOMMENDATION**

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on March 31, 2015 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

# BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

#### 1. No Parking

Upon review a typographical error was discovered for Charles Street No Parking 12:00 am to 3:00 pm Monday to Saturday, it should read 12:00 am to 3:00 am Monday to Saturday.

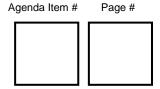
Due to a driveway entrance expansion at St. Joseph's Hospital on College Avenue it is recommended to implement a 'No Parking Anytime' zone by removing the '2 Hour Metered Parking' stall closest to the driveway to avoid potential conflict with parked vehicles and large delivery trucks utilizing that driveway.

At the request of local residents, a mail-back survey was sent to the property owners at the following locations, and a majority consensus was met agreeing to the proposed changes:

- To add 'No Parking Anytime' on the south side of Corley Drive;
- To remove the 'No Parking Anytime' zone on the north side of Duchess Avenue from Wharncliffe Road South to Edward Street; and
- To add a 'No Parking 8:00 am to 9:00 am and 3:00 pm to 4:00 pm Monday to Friday from September 1<sup>st</sup> to June 30<sup>th</sup>' on the west side of Pinetree Drive from the north limit to Oban Crescent.

Due to safety concerns, it is recommended that 'No Parking Anytime' zones be implemented at the following locations:

- The south side of Fullarton Street from Talbot Street to 22 meters west of Talbot Street, stall in front of fire hydrant;
- The inside of the curves at #1505, #1711, and #1777 Mickleborough Drive,
- The north side of Kenneth Avenue from Wellington Street to 32 meters east of Wellington Street; and



 The north side of Waterman Avenue from Wellington Road to 96 meters west of Wellington Road.

Amendments are required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking) for the above changes.

#### 2. Prohibited Turns

As part of the new development on the north-east corner of the Oxford Street East and Waterloo Street intersection, a right-in/right-out only entrance was approved and constructed.

An amendment is required to Schedule 8 (Prohibited Turns) to prohibit left-turns at the above noted entrance.

### 3. Regulatory Signs

Due to operational and safety concerns, it is proposed to replace existing Yield Sign with a Stop Sign at the following locations:

- Northbound and southbound Pleasantview Drive at Waterwheel Road; and
- Northbound Foxwood Avenue at Silverfox Drive.

An amendment is required to Schedule 10 (Stop Signs) and Schedule 11 (Yield Signs) for the above changes.

### 4. <u>Designated Parking Spaces - Disabled Persons</u>

Staff received a request to install an accessible parking space at the following locations:

- North side of Fullarton Street west of Richmond Street:
- North side of Queens Avenue east of Talbot Street; and
- East side of Talbot Street south of York Street.

It should be noted that the above changes are consistent with the requirements of the Accessibility for Ontarians with Disabilities Act (AODA),

An amendment is required to Schedule 5 (Loading Zones) and Schedule 27 (Designated Parking Spaces – Disabled Persons) for the above changes.



# APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. Of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:


