NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law Z.-1. The requested change is described below. We are advising you of this application to invite your comments.

APPLICANT:	City of London
LOCATION:	City-wide
PURPOSE AND EFFECT:	The purpose and effect of the requested Zoning By-law amendment is to provide regulations regarding greenhouses and the greenhouse coverage limit. The purpose and effect of the proposed zoning by-law amendment would be to increase the lot coverage for greenhouse uses beyond the 10% (maximum) lot coverage currently permitted.
POSSIBLE AMENDMENT:	Possible changes to Zoning By-law Z.1 to amend Section 2 – Definitions, Section 4 – General Provisions, Section 45 - Agricultural (AG) Zone, and Section 46 Agricultural Commercial (AGC) Zone to provide regulations for greenhouses.
PLANNING POLICIES:	Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document.
