My name is Bob Young. My wife Mary Eileen and I have been at 2135 Wallingford Ave for over 2 years.

We are approximately 100 yds from the new proposed solid 8' privacy wall.

Here are some of the reasons we are supporting Rembrandt's construction of an 8' privacy wall.

- Privacy - to enjoy our new home.
 - no gate entrance to Wonderland Rd
- Security - from intruders
 - no gate entrance to Wonderland Rd.
- Peace of mind.
 - no gate entrance to Wonderland Rd.

These gates would negate the effectiveness of a solid wall.

We understand that the proposed wall also has a sound barrier feature as well.

Problem

The issue now is increased traffic due to the building explosion in the North end. We now have extreme noise that rips through our home making it difficult at times to hold a normal conversation.
