BACKGROUND

Purpose:

This report is submitted to seek Council approval to enter into a formal contract with SDI Builders Ltd., for the Victoria Park Bandshell Renovation.

Discussion:

The proposed renovations incorporate life cycle renewal works to the male and female public washrooms, the concession booth and the refrigeration room and they include:

- · Replacement of washroom fixtures
- New windows to replace existing
- Painting
- Construction of a secondary exit from the refrigeration room
- New sinks and millwork for the concession booth

Tenders for the Victoria Park Bandshell Renovation were received January 18, 2012. The bid submitted by SDI Builders Ltd., was the lowest of 10 bids received and meets the City's specification and requirements in all areas. A summary of bids received is attached as Appendix "B".

The bid submitted by SDI Builders Ltd., offers the best value to the City and it is recommended that they be awarded a contract for the work in accordance with Section 13 of the Procurement of Goods and Services Policy.
