4. Council Procedure By-Law No. A-45

- a) review and report back on how section 21 "Enactment of By-laws" could be amended to provide for the debate of the enactment of by-laws to occur at the same time as the Standing Committee recommendation related to the by-law is being debated or at a subsequent Council meeting, after the Council meeting where the recommendation of the Standing Committee related to the matter has been considered by Council;
- b) bring forward consideration of section 23 "Striking Committee" at a future meeting of the Governance Working Group (GWG) after the GWG has discussed matters related to advisory committees; and,
- c) amend section 24 "Standing Committee Meetings" to provide for the inclusion of comprehensive procedural rules to be followed at Standing Committee meetings to alleviate the need to cross reference various sections set out in the Council Procedure By-law.
