

By-law No.

A by-law to amend By-law No. A.-6724-281, entitled "A By-law to ratify, confirm and approve various agreements between Hewlett-Packard Financial Services Canada Company (HPFS) and The Corporation of the City of London for the leasing of computer equipment; and to authorize the Mayor and City Clerk to execute the agreements."

WHEREAS subsection 5(3) of the *Municipal Act, 2001* provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* S.O. 2001, c.25 provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS sections 9 and 10 and 23.1 through 23.5 of the *Municipal Act, 2001* authorize a municipality to delegate its powers and duties under this or any other Act to a person or body;

AND WHEREAS Council has passed By-law A.-6151-17 to implement a policy for the "Delegation of Powers and Duties" that provides any delegation of a power or duty shall be by by-law;

NOW THEREFORE the Council of the Corporation of the City of London enacts as follows:

- 1. By-law No. A.-6724-281 is amended as follows:
 - a) by amending Section 2. (b) by deleting the words "Chief Technology Officer, or written designate" and replacing them with the words "City Treasurer or Director, Information Technology or designate";
 - b) by amending Section 4. (b) by deleting the words "Chief Technology Officer, or written designate" and replacing them with the words "City Treasurer or Director, Information Technology or designate";
 - by amending Section 4. (b) (iii) by deleting the words "Chief Technology Officer, or designate" and replacing them with the words, "City Treasurer or Director, Information Technology or designate"; and
 - d) by amending Section 5. (b) by deleting the words "Chief Technology Officer, or written designate" and replacing them with the words "City Treasurer or Director, Information Technology or designate";
- This by-law shall come into force and effect on the day it is passed.
