That the City Clerk BE REQUESTED to amend Council Policy 5(34) "Appointment of Council Members to Standing Committees of Council and Various Civic Boards and Commissions" to reflect the current Standing Committee structure and appointment process.

7. Recruitment Process for Advisory Committees, Boards, Commissions and Striking Committee Terms of Reference

That the Civic Administration BE REQUESTED to undertake the following actions with respect to the recruitment process for Advisory Committees, Boards, Commissions and Striking Committee Terms of Reference:

 the City Solicitor's Office BE REQUESTED to review and report back to the Governance Working Group (GWG) regarding the recommendation from the Striking Committee that applicants be requested to voluntarily disclose information pertaining to diversity;

- b) the City Clerk and the City Solicitor's Office BE REQUESTED to review and report back to the Governance Working Group (GWG) regarding the processes undertaken by other municipalities with respect to Council appointments to Advisory Committees, Boards and Commissions and provide a recommendation regarding best practices that could be considered to ensure a transparent, streamlined and fair process for appointments; it being noted that the review is to consider, but not be limited to, the following matters:
 - i) staggered term appointments to provide for appointments to be made at the beginning and middle of each term of Council so that the process is not onerous:
 - ii) membership of the Striking Committee:
 - provisions that restrict Striking Committee members from being appointed to Advisory Committees, Boards or Commissions;
 - iv) possible creation of a different type of committee structure for appointments;
 - v) a process that provides for the short listing of applicants;
 - vi) an interview process for applicants;
 - vii) an improved communications and recruitment process;
 - viii) clear and plain language descriptions of the role of the Advisory Committees, Boards and Commissions; and,
 - ix) clearer guidelines with respect to the disclosure of potential conflicts of interest by appointed Advisory Committee members.

That the review of a process for the provision of a current list of projects to Members of Council BE DEFERRED to the October 28, 2015 meeting of the Governance Working Group (GWG) for further discussion; it being noted that input from the City Manager will be sought at that time.
