 - iv) delete all references to the title "Director, Development and Compliance" and replace them with the title "Managing Director, Development and Compliance Services and Chief Building Official"; and
 - v) delete section 7.1 in its entirety and replace it with a new section 7.1 to reflect the title changes noted in sections i) to iv), above;

Bill No. XXX 2015

By-law No. C.P.-1363(X)-XX

A by-law to amend By-law No. C.P.-1363-381 entitled "The City of London Site Alteration By-law".

WHEREAS section 23.1 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that Municipal Council is authorized to delegate its powers and duties under this or any other Act to a person or body subject to any restrictions set out;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. Section 1.1 of By-law C.P.-1363-381, as amended, is hereby further amended by adding the following definition:

""Manager, Development Services and Planning Liaison" shall mean the person who holds the position of Manager, Development Services and Planning Liaison for The Corporation of the City of London."

- 2. Section 7-1 of By-law C.P.-1363-381, as amended, by deleting it in its entirety and by replacing it with the following new section 7.1:
 - "7.1 Administration and enforcement of by-law absence The administration and enforcement of this bylaw shall be performed by the Managing Director, Development and Compliance Services and Chief Building Official. When the Managing Director, Development and Compliance Services and Chief Building Official is absent or his office is vacant then the Manager, Development Services Engineering Liaison, or when his office is vacant the Manager, Development Services and Planning Liaison shall act in the place and stead of the Managing Director, Development and Compliance Services and Chief Building Official under this by-law and while so acting has and may exercise all the rights, powers and authority of the Managing Director, Development and Compliance Services and Chief Building Official as delegated by this by-law subject to the same responsibilities and limitations set out in this by-law."
- 3. By-law No. C.P.-1363-381, as amended, is hereby further amended, by deleting all references to the term "Director, Development and Compliance" and by replacing them with the term "Managing Director, Development and Compliance Services and Chief Building Official".
- 4. This by-law comes into force and effect on the date that it is passed.

- 3. Part 1 of By-law C.P.-1470-218, as amended, is hereby further amended by adding the following definition:
 - ""Manager, Urban Regeneration" shall mean the person who holds the position of Manager, Urban Regeneration for the Corporation of the City of London"
- 4. Part 4 of By-law C.P.-1470-218, as amended, is hereby further amended by deleting section 4.1 in its entirety and by replacing it with the following new section 4.1:
 - "4.1 Acceptance Authority Delegation

The Manager, Current Planning, the Manager, Long Range Planning and Research, the Manager, Urban Regeneration, the Manager, Development Services and Planning Liaison, or a person who holds the position as a Manager, Development Planning may exercise all the rights, powers and authority of the City Planner as delegated by this by-law subject to the same responsibilities and limitations set out in this by-law."

A by-law to amend By-law CP-17 entitled the "Subdivision and Condominium Delegation and Approval By-law"

WHEREAS subsection 51.2(1) of the *Planning Act*, R.S.O. 1990, c. P.13, as amended, provides that a municipal council may by by-law delegate to an appointed officer identified in the by-law either by name or position occupied, the authority to approve plans of subdivision including plans of condominium;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts amendments to By-law No. CP-17, as amended, entitled the "Subdivision and Condominium Delegation and Approval By-law" as follows:

1. Section 1.1 is hereby amended by deleting the entire definition for "Manager Community Planning and Design – defined" and by replacing it with the following new definition:

"Manager, Development Planning - defined Manager, Development Planning" shall mean the person who holds the position of Manager, Development Planning for The Corporation of the City of London""

- 2. Section 1.1 is hereby amended by deleting the entire definition for "City Planner defined".
- 3. Section 1.1 is hereby amended by deleting the entire definition for "Planning Director defined".
- 4. Section 3.1 is hereby deleted in its entirety and be replaced with the following new section 3.1::
 - "3.1 Approval Authority Manager, Development Services and Planning Liaison Absence

When the Manager, Development Services and Planning Liaison is absent or his office is vacant, the Manager, Development Planning shall act in the place and stead of the Manager, Development Services and Planning Liaison under this bylaw and while so acting, the Manager, Development Planning has and may exercise all the rights, powers, and authority of the Manager, Development Services and Planning Liaison as delegated by this by-law subject to the same responsibilities and limitations as set out in Part 2 of this by-law."

- 5. By-law CP-17, as amended, is hereby further amended by deleting all references to the term "of Planning and Development".
- 6. By-law CP-17, as amended, is hereby further amended by deleting all references to the title "General Manager" and by replacing them with the title "Manager, Development Services and Planning Liaison".

- 7. By-law CP-17, as amended, is hereby further amended by deleting all references to the title "City Planner" and by replacing them with the title "Manager, Development Services and Planning Liaison".
- 8. This by-law comes into force and effect on the date that it is passed.
