The City of London is planning to redesign the first four blocks of Dundas Street, from Wellington Street to the Thames River, so the street can also serve as a people-oriented destination called “Dundas Place”. Transforming Dundas Street is the first project in Our Move Forward: London’s Downtown Plan.

Dundas Place will be designed to accommodate pedestrians, cyclists and vehicles in a safe and comfortable way. It is intended to be a public amenity for those living in the downtown neighbourhood and provide a space to program events and attract visitors throughout the year.
