- a) The budget for ESSWM-DCNLP9 SWMF Dingman Creek North Lambeth No. P9 is included in the 2016 proposed budget. It is 100% funded by Development Charges. There will be no impact on the rate supported budget from this revision. A portion of this budget (\$321,960) is required in 2015 and can be accommodated by advancing the required amount from the 2016 budget. Upon Council approval of this recommendation, the 2016 proposed budget for project ESSWM-DCNLP9 will be automatically revised.
- b) The budget for ESSWM-PKR SWMF Parker is included in the 2017 proposed budget. It is 100% funded by Development Charges. There will be no impact on the rate supported budget from this revision. A portion of this budget (\$48,076) is required in 2015 and can be accommodated by advancing the required amount from the 2017 budget. Upon Council approval of this recommendation, the 2017 proposed budget for project ESSWM-PKR will be automatically revised.
- c) The budget for ESSWM-PD3 SWMF Pincombe Drain No. 3 is included in the 2017 proposed budget. It is 100% funded by Development Charges. There will be no impact on the rate supported budget from this revision. A portion of this budget (\$108,999) is required in 2015 and can be accommodated by advancing the required amount from the 2017 budget. Upon Council approval of this recommendation, the 2017 proposed budget for project ESSWM-PD3 will be automatically revised.
- d) The budget for ESSWM-SC2 SWMF Stoney Creek No. 2 is included in the 2016 proposed budget. It is 100% funded by Development Charges. There will be no impact on the rate supported budget from this revision. A portion of this budget (\$1,046) is required in 2015 and can be accommodated by advancing the required amount from the 2016 budget. Upon Council approval of this recommendation, the 2016 proposed budget for project ESSWM-SC2 will be automatically revised.

- Administration hereby certifies that the estimated amounts payable in respect of this project does not exceed the annual financial debt and obligation limit for the Municipality of Municipal Affairs in accordance with the provisions of Ontario Regulation 403/02 made under the Municipal Act, and accordingly the City Clerk is hereby requested to prepare and introduce the necessary authorizing by-laws.
- a) The City Clerk be authorized to increase Debenture By-law No. W.-5584-183 by \$321,960 from \$262,815 to \$584,775.
- b) An authorizing by-law should be drafted to secure debenture financing for project ESSWM-PKR SWM Facility Parker for the net amount to be debentured of \$703.076.
- An authorizing by-law should be drafted to secure debenture financing for project ESSWM-PD3 SWM Facility Pincombe Drain No. 3 for the net amount to be debentured of \$475,999.
- An authorizing by-law should be drafted to secure debenture financing for project ESSWM-SC2 SWM Facility Stoney Creek No. 2 for the net amount to be debentured of \$300,046.
